Chair Anderson recognized Representative Hagenow for opening comments on HSB 151. Representative Hagenow was recognized for opening comments on Amendment 151.981. Amendment .981 passed by a voice vote. Discussion on HSB 151 followed. Representative Hagenow was recognized for closing comments on HSB 151. Representative Hagenow moved HSB 151 as amended. HSB 151 passed the Judiciary Committee 21-0. Chair Anderson announced that HSB 151, having received a constitutional majority would pass to the Floor of the House as a committee bill.

Chair Anderson recognized Representative Garrett for opening comments on HSB 166. Discussion on HSB 166 followed.

Representative Garrett was recognized for closing comments on HSB 166. Representative Garrett moved HSB 166. HSB 166 passed the Judiciary Committee 21-0. Chair Anderson announced that HSB 166, having received a constitutional majority would pass to the Floor of the House as a committee bill.

Chair Anderson recognized Representative Massie for opening comments on HSB 174. Representative Massie was recognized for opening comments on Amendment 174.961. Amendment .961 passed by a voice vote. Discussion on HSB 174 followed. Representative Massie was recognized for closing comments on HSB 174. Representative Massie moved HSB 174 as amended. HSB 174 passed the Judiciary Committee 21-0. Chair Anderson announced that HSB 174, having received a constitutional majority would pass to the Floor of the House as a committee bill.

Chair Anderson recognized Representative Pearson as temporary chair. Acting Chairperson Pearson recognized Representative Anderson for opening comments on HSB 42. Representative Anderson was recognized for opening comments on Amendment 42.945. Amendment .945 passed by a voice vote. As there was no discussion, Representative Anderson was recognized for closing comments on HSB 42. Representative Anderson moved HSB 42 as amended. HSB 42 passed the

Judiciary Committee 21-0. Acting Chair Pearson announced that HSB 42, having received a constitutional majority would pass to the Floor of the House as a committee bill.

Chair Anderson asked for unanimous consent to consider HSB 165. With unanimous consent, Chair Anderson recognized Representative Kaufmann for opening comments on HSB 165. Representative Kaufmann stated that HSB 165 would be amended on the Floor. As there was no discussion, Representative Kaufmann was recognized for closing comments on HSB 165. Representative Kaufmann moved HSB 165. HSB 165 passed the Judiciary Committee 21-0. Chair Anderson announced that HSB 165, having received a constitutional majority would pass to the Floor of the House as a committee bill.

Chair Anderson recognized Representative Garrett for opening comments on HSB 44. Representative Taylor was recognized for opening comments on Amendment 44.916. Discussion on Amendment .916 followed. The result of a voice vote on Amendment .916 was questionable, so a roll call vote was taken. Amendment .916 passed 12-9, those voting nay were Representatives Swaim, Gaines, Lensing, Oldson, Olson, R., Olson, T., Smith M., Wessel-Kroeschell and Wolfe. Chair Anderson then recognized Representative Garrett for opening comments on Amendment 44.966. Discussion on amendment .966 followed. Amendment .966 passed by a voice vote. Discussion on HSB 44 followed. Representative Garrett was recognized for closing comments on HSB 44. Representative Garrett moved HSB 44 as amended. HSB 44 passed the Judiciary Committee 14-7, those voting nay were Representatives Gaines, Lensing, Oldson, Olson, R., Olson, T., Wessel-Kroeschell, and Wolfe. Chair Anderson announced that HSB 44, having received a constitutional majority would pass to the Floor of the House as a committee bill.

Chair Anderson recognized Representative Garrett for opening comments on HSB 88. Representative Garrett was recognized for opening comments on Amendment 88.891. Amendment .891 passed by a voice vote. Discussion on HSB 88 followed. Representative Garrett was recognized for closing comments on HSB 88. Representative Garrett moved HSB 88 as amended. HSB 88 passed the Judiciary Committee 17-4, those voting nay were Representatives Heaton, Olson,R., Smith,M., and Wessel-Kroeschell. Chair Anderson announced that HSB 88, having received a constitutional majority would pass to the Floor of the House as a committee bill.

There being no further business to come before the committee, Representative Massie moved to adjourn.
