Chair Baudler called the meeting to order at 10:20AM.

Roll call was taken and a quorum was present.

As there were no corrections, amendments, and/or deletions to the March 1st meeting minutes, they were unanimously approved.

The Democrats and Republicans had a short caucus at 10:25AM and Chair Baudler called the meeting back to order at 10:45AM.

Representative Baudler then recognized Representative Alons for HSB 152 at which time Representative Alons asked to be recognized for Amendment 969, a strike-after amendment to HF 152. The Chair recognized Representative Alons for the amendment, and after explaining the amendment it passed unanimously through the committee. The chair recognized Representative Alons for HSB 152 as amended. Representative Alons moved the bill. HF 152 was voted on, and passed 19-2. Those voting no were Representative Olson, R. and Representative Wolfe. This bill will move to the House floor as a Committee bill.

Representative Baudler then recognized Representative Fry for HSB 153 at which time Representative Fry asked to be recognized for Amendment 980, a strike-out amendment to HF 153. The Chair recognized Representative Fry for the amendment, and after explaining the amendment it passed unanimously through the committee. The chair recognized Representative Fry for HSB 153 as amended. After discussion on the bill Representative Fry moved the bill. HF 153 was voted on, and passed unanimously 21-0. This bill will move to the House floor as a Committee bill.

The Chair Baudler announced a subcommittee of the whole and Representative Olson, S. seconded the motion. After unanimous consent, the meeting was moved to a subcommittee of the whole and HSB 204 was passed out of subcommittee of the whole. Representative Windschitl then moved that the subcommittee of the whole is adjourned and the meeting to continue, and after unanimous consent the subcommittee of the whole was adjourned and the meeting continued.

Representative Baudler then recognized Representative Shaw for HSB 204. Representative Shaw then moved the bill, seeing as how discussion took place during the subcommittee of the whole. HSB 204 was voted on, and passed unanimously 21-0. This bill will move to the House floor as a Committee bill.

As there was no other business to come before the committee, Representative Olson, S. moved we adjourn. The meeting was adjourned at 11:15AM.
