Chairman Representative Sands called the meeting to order at 9:40 AM

Attendance was taken and quorum was present.

As there were no corrections, amendments and/or deletions to the March 22nd meeting minutes, they were unanimously approved.

Chairman Sands asked for unanimous consent to place HF 500 on the agenda.

Meeting recessed at 9:45 AM for both parties to caucus.

Meeting reconvened at 10:20 AM.

The chair recognized Representative Hein for opening remarks on HF 402. A bill for an act relating to certain fees assessed for activities regulated under the federal Clean Air Act. (Formerly HSB 75) Representative Hein moved the bill. The bill passed by the vote of 14 Aye to 9 Nay with 2 Absent. The nays were Jacoby, Isenhart, Kajtazovic, Kearns, Muhlbauer, Oldson, Petersen, Thomas, and Willems. The bill will move to the house floor as a committee bill.

Chairman Sands turned the chair over to Representative Byrnes.

Chairman Byrnes requested that the committee dissolve into a Sub Committee of the Whole for Consideration of HF 500.

The Chair recognized Representative Sands for opening comments and explanation on HF 500. After discussion, the bill was moved and passed on a voice vote.

The Sub Committee of the Whole dissolved back into the Committee.

The Committee reconvened.

The chair recognized Representative Sands for opening remarks on HF 500. This bill relates to rulemaking authority of the department of natural resources and including effective date and applicability provisions. The chair recognized Representative Sands for introduction of Amendment 1998. The amendment passed on short form.

Representative Sands moved the bill as amended. The bill passed by the vote of 15 Aye to 9 Nay and 1 Absent. The nay votes were Jacoby, Isenhardt, Kajtazovic, Kearns, Muhlbauer, Oldson, Petersen, Thomas and Willems. This bill will move to the house floor as a committee bill as amended.

Chairman Byrnes turned the chair over to Representative Sands.

As there was no additional business to come before the committee Representative Cownie moved to adjourn at 11:10 AM.
