

## COMMITTEE MINUTES for PUBLIC SAFETY

Chair Baudler called the meeting to order at 4:00PM.

Roll call was taken and a quorum was present. Representative Swaim, Representative Sands, and Representative Tjepkes were excused.

As there were no corrections, amendments and/or deletions to the January 18, 2012 minutes, they were unanimously approved.

The following study bill was assigned to the following subcommittee:  
HSB 545 (Chair: Brandenburg, Tjepkes, Abdul-Samad)

Chair Baudler and Ranking Member Kressig announced the caucus of their respective parties at 4:05PM

The meeting reconvened at 4:35PM.

Chair Baudler recognized Representative Worthan for consideration of HF 278, a bill for an act relating to eluding or attempting to elude a marked law enforcement vehicle, and providing a penalty.

Chair Baudler recognized Representative Worthan for consideration of Amendment 3470 to HF 278. Representative Worthan yielded to questions from the committee on the amendment. After questions from the committee, Representative Worthan moved the amendment. The amendment passed unanimously with a voice vote.

Chair Baudler recognized Representative Worthan for HF 278 as amended. Representative Worthan moved HF 278. The bill did not receive an affirmative vote of a majority of the committee membership as required to report a bill out of committee. Those voting aye were: Chair Baudler, Vice Chair Shaw, Representative Alons, Representative Brandenburg, Representative Fry, Representative Klein, Representative Olson, S., Representative Rayhons, Representative Windschitl, and Representative Worthan.

Those voting nay were: Ranking Member Kressig, Representative Abdul-Samad, Representative Berry, Representative Gaines, Representative Hagenow, Representative Muhlbauer, Representative Olson, R., and Representative Wolfe. Representative Sands, Representative Swaim, and Representative Tjepkes were excused.

Chair Baudler recognized Representative Klein for consideration of HF 520, a bill for an act relating to the carrying of weapons on school grounds by licensed private investigators and licensed private security officers.

Chair Baudler recognized Representative Klein for Amendment 3480 to HF 520. Amendment 3480 passed unanimously with a voice vote.

Representative Klein yielded to questions from the committee.

Chair Baudler recognized Representative Klein for consideration of HF 520 as amended. Representative Klein moved HF 520.

HF 520 passed as amended. Those voting aye were: Chair Baudler, Vice Chair

Shaw, Ranking Member Kressig, Representative Abdul-Samad, Representative Alons, Representative Berry, Representative Brandenburg, Representative Fry, Representative Hagenow, Representative Klein, Representative Muhlbauer, Representative Olson, R., Representative Olson, S., Representative Rayhons, Representative Windschitl, Representative Wolfe, and Representative Worthan. Representative Gaines voted nay. Representative Sands, Representative Swaim, and Representative Tjepkes were excused.

The bill will move to the House Floor.

Chair Baudler recognized Representative Muhlbauer for the introduction of Donna Wood and David Stark of Blank Children's Hospital for a presentation.

As there was no additional business to come before the committee, Representative Olson, S. moved to adjourn. The committee was adjourned at 5:00PM.
