The meeting was called to order at 1:05 P.M.

Roll call was taken and a quorum was present.

Chair Baudler and Ranking Member Kressig announced the caucus of their respective parties at 1:10 P.M.

The committee reconvened at 1:50 P.M.

Chair Baudler recognized Representative Fry for consideration of HF 183 a bill for an act relating to the control of marijuana, including an effective date provision, and providing a penalty. Chair Baudler recognized members of the committee for discussion on HF 183. Chair Baudler recognized Representative Fry for final comments on the bill. Representative Fry moved the bill.

Having received an affirmative vote of a majority of the committee membership as required to report a bill out of committee, HF 183 moved to the House Floor.

Chair Baudler recognized Representative Tjepkes for consideration of HSB 526 by Tjepkes a study bill relating to requirements for a motor vehicle operator to have control of the vehicle at all times and to reduce speed in specific situations. Representative Tjepkes made opening comments on the bill. Chair Baudler recognized Representative Tjepkes for consideration of Amendment HSB 526.3630. The amendment passed unanimously with a voice vote. Chair Baudler recognized Representative Tjepkes for closing comments on HSB 526. Representative Tjepkes moved the bill.
