Chair Anderson announced that consideration of HSB 524 and HSB 563 will be deferred.

Chair Anderson recognized Representative Rogers for opening comments on HF 627. Representative Rogers was recognized for opening comments on Amendment .3507. As there was no discussion, Representative Rogers moved passage of Amendment.3507. The amendment passed by a voice vote. Discussion of HF 627 as amended followed. Representative Wolfe requested unanimous consent to recognize the Iowa Attorney General for a question. With unanimous consent, Deputy Attorney General Eric Tabor was recognized and responded to Representative Wolfe's questions. Representative Rogers agreed that HF 627 will be amended before being debated on the floor to address an issue that was discussed. Representative Rogers was recognized for closing comments on HF 627. Representative Rogers moved HF 627. HF 627 passed the Judiciary Committee 21-0 as amended. Chair Anderson announced that HF 627, having received a constitutional majority would pass to the Floor of the House as a committee bill.
