Representative Forristall (CH) called the meeting to order at 4:00 PM.

Attendance was taken.

The minutes of the previous meeting were approved.

Representative Forristall (CH) turned the chair over to Representative J. Taylor (VC). Representative J. Taylor recognized Representative Forristall for opening remarks on HSB 588. The committee went to caucus at 4:10.

The committee reconvened at 4:30, and Representative J. Taylor recognized Representative Steckman for opening remarks on Amendment 3645. Discussion followed. Representative Steckman was recognized for closing comments by the Chair and moved the Amendment. Amendment 3645 failed on a roll call vote with 9 Ayes (Representatives Steckman, Abdul-Samad, Cohoon, Gaines, Hanson, Kelley, Mascher, Willems and Winckler), 13 Nays, and one member absent (Byrnes).

The Chair recognized Representative Forristall for opening comments on HSB 588 ( an act relating to requirements for the enactment of the state percent of growth and the categorical state percent of growth and including effective date provisions). After some discussion Representative Forristall made closing comments and moved HSB 588. On a roll call vote HSB 588 passed with 13 Ayes, 9 Nays (Representatives Steckman, Abdul-Samad, Cohoon, Gaines, Hanson, Kelley, Mascher, Willems and Winckler) and one member absent (Byrnes). Having received a constitutional majority, HSB 588 will pass to the Floor of the House as a committee bill.

AS there was no other business to come before the committee, Representative Lofgren moved for adjournment at 4:45 PM.
