Upon completion of the caucuses at 4:35 p.m., Rep. Soderberg recognized Rep. Chip Baltimore for an introduction of HSB 572. Rep. Baltimore introduced Amendment 3903. Following discussion, Rep. Baltimore moved the amendment. Amendment 3903 passed on a short form voice vote. Rep. Soderberg opened the floor to discussion of HSB 572, as amended. Following discussion, Rep. Soderberg recognized Rep. Baltimore for closing remarks. Rep. Baltimore then moved the bill. Roll was called. With a vote of 22 ayes and 0 nays, the bill was declared to have passed the committee and will move to the House floor as a committee bill as amended.

Rep. Soderberg recognized Rep. Jeff Smith for an introduction of HSB 635. Following discussion, Rep. Soderberg recognized Rep. Smith for closing comments. Rep. Smith then moved the bill. Roll was called. With a vote of 22 ayes and 0 nays, the bill was declared to have passed the committee and will move to the House floor as a committee bill.

Rep. Soderberg recognized Rep. Stewart Iverson for an introduction of HSB 558. Rep. Iverson signified an amendment for HSB 558. Chairman Soderberg recognized Rep. Lance Horbach for introduction of Amendment 4139. Following discussion, Rep. Horbach moved the amendment. Amendment 4139 passed on a short form voice vote. Rep. Soderberg opened the floor to discussion of HSB 558, as amended. Following discussion, Rep. Soderberg recognized Rep. Iverson for closing remarks. Rep. Iverson then moved the bill. Roll was called. With a vote of 22 ayes and 0 nays, the bill was declared to have passed the committee and will move to the House floor as a committee bill.
