Chair Baudler recognized Vice Chair Shaw for closing comments on the amendment. Vice Chair Shaw moved Amendment 4279. Amendment 4279 to HSB 603 passed unanimously with a voice vote. Chair Baudler recognized members of the committee for discussion on the bill as amended. Chair Baudler recognized Vice Chair Shaw for closing comments on HSB 603 as amended. Vice Chair Shaw moved the HSB 603 as amended. Chair Baudler recognized Representative Fry for closing comments on Amendment 3760. Representative Fry moved amendment 3760. Amendment 3760 passed unanimously with a voice vote. Chair Baudler recognized Representative Fry for closing comments on HSB 609 as amended. Representative Fry moved HSB 609 as amended.
