The Chair recognized Representative Rogers for consideration of HJR 2006, a Joint Resolution proposing amendments to the Constitution of the State of Iowa relating to state budgeting by creating a state general fund expenditure limitation, providing for a taxpayers relief fund, requiring authorization for certain bonds, and restricting certain state revenue changes. The Chair recognized Representative Rogers for opening remarks on amendment HJR 2006.4479. Following discussion, Representative Rogers moved the amendment, which passed, short form. Following committee discussion, Representative Raecker recognized Representative Rogers for closing remarks on HJR 2006. Representative Rogers moved HJF 2006, which passed, 15-10.
