Representative Jorgensen was recognized for SF 2121. A bill for an act relating to the title of the office of citizens' aide. The subcommittee report was submitted and signed by Rep. Jorgensen, Drake and Hunter. Rep. Jorgensen gave opening comments, discussion followed and with closing remarks moved SF 2121. Chair Cownie moved SF 2121, to the calendar on a roll call vote. Motion carried with 21 ayes, 1 nay (Isenhart), 1 absent.

Representative Koester was recognized for SF 364. A bill for an act relating to the licensure of orthotists, prosthetists, and pedorthists and providing for fees and penalties. The subcommittee report was submitted and signed by Rep. Koester, Massie and Wenthe. Rep. Koester gave opening comments and asked permission to take up amendment .3575. Discussion followed and amendment .3575 was adoped, and with closing remarks moved SF 364 as amended. Chair Cownie moved SF 364 as amended, to the calendar on a roll call vote. Motion carried with 21 ayes, 1 nay (Schulte), 1 absent.

With no further business to come before the Committee, Chair Cownie moved for adjournment. Representative Kaufmann seconded the motion.
