Representative Raecker called the Appropriations Committee meeting to order at 10:05 AM. Roll was called; quorum present. Minutes from the March 21, 2012 meeting were approved.

Republicans and Democrats went to caucus at 10:09 AM.

Representative Raecker reconvened the meeting at 11:30 AM.

Representative Raecker recognized Representative Schulte for opening remarks on SF 2315, an Act relating to redesign of publicly funded mental health and disability services by requiring certain core services and addressing other services and providing for establishment of regions and including effective date and applicability provisions. Representative Schulte was recognized for opening remarks on amendment SF 2315.5328. Discussion followed. Representative Schulte was recognized for closing remarks and moved the amendment, which passed, short form. Representative Raecker returned the committee to SF 2315. With no further closing comments, Representative Schulte moved the bill, which passed, 19-5. Representatives voting yes: Raecker, Wagner, Chambers, Dolecheck, Drake, Garrett, Hagenow, Heaton, Heddens, Huseman, Lukan, Murphy, Rogers, Schulte, Schultz, Watts, Wenthe, Winckler, Worthan. Representatives voting nay: Olson, Cohoon, Gaskill, Hall, Taylor. Excused: Running-Marquardt. SF 2315, as amended, will move to the House floor.

Representative Raecker recognized Representative Dolecheck for opening remarks on SF 2219, an Act relating to the continuation of the Iowa early intervention block grant program and including effective date provisions. Representative Raecker recognized Representative Dolecheck for opening remarks on amendment SF 2219.5329. Discussion followed. Representative Dolecheck was recognized for closing remarks on the amendment, which passed, 15-9. Representatives voting aye: Raecker, Wagner, Chambers, Dolecheck, Drake, Garrett, Hagenow, Heaton, Huseman, Lukan, Rogers, Schulte, Schultz, Watts, Worthan. Representative Raecker requested and received unanimous consent to dissolve the committee into a subcommittee of the whole. Representative Raecker recognized Representative Huseman for opening remarks on SF 2316, an Act relating to and making appropriations to state departments and agencies from the rebuild Iowa infrastructure fund, the technology reinvestment fund, the FY 2009 prison bonding fund, and the endowment for Iowa's health restricted capitals fund, providing for related matters, and including effective date and retroactive applicability provisions. Representative Huseman was recognized for closing remarks and moved the bill, which passed, short form.

Representative Raecker requested and received unanimous consent to dissolve the subcommittee of the whole and return to the full committee. With no further opening remarks on SF 2316, Representative Huseman was recognized for opening remarks on amendment SF 2316.5308. Following discussion, Representative Huseman was recognized for closing comments and moved the amendment, which passed, short form. Representative Raecker returned the committee to SF 2316 and recognized Representative Huseman for closing comments. Representative Huseman moved the bill, which passed, 14-11. Representatives voting aye: Raecker, Wagner, Chambers, Dolecheck, Drake, Garrett, Hagenow, Heaton, Huseman, Rogers, Schulte, Schultz, Watts, Worthan.
