We appreciate the inclusion of Division II, the Child Care Challenge Fund, which should help increase the availability of quality options for child care in the state.2. Regarding Division IV, Computer Science Instruction, the bill adds a requirement for schools to add computer science instruction in at least one grade level during elementary school, one grade level during middle school, and adds a requirement for a half unit of computer science instruction during high school. Most Catholic schools already have these courses, but our concern is that adding any new course mandates during the school day necessarily has to take away from something else. Some other course area or elective has to give way. At least one high school is shortening class periods to create another period in part because of other recentlyadded mandates. We would appreciate removing the "offer and teach" mandate.

When we were last discussing this bill in late February, both UEN and RSAI members would support the bill including mandate of computer science with addition of an amendment to allow local control to decide how best to offer courses for which finding teachers is challenging or for which an online learning environment is ideal, such as world languages (256.11 subsection 5.f.), financial literacy (256.11 subsection 5.k) and the new proposed computer science online. We also support changes to section 20 regarding Senior Year Plus post secondary enrollment, to maintain the parttime limitation of such enrollment, but to create an exception for local school boards working in partnership with their community colleges and the private sector to allow for fulltime enrollment under certain circumstances. With these two changes, both organizations will be supportive.
