Distress in England

LONDON, March 20.—The distress throughout the industrial districts of the United Kingdom because of the coal strike which has thrown 1,000,000 miners and over 1,500,000 other workmen out of employment, is acute. While the delegates of the miners and mine owners are discussing with politicians the minimum wages bill, women, children and the workers themselves in many places are suffering extreme poverty and appeals are constantly reaching London, which appears to be the least affected of the large cities, for assistance.

The Earl of Harrowby, who has just toured the potter districts in Staffordshire, is asking for funds, says thousands of children in the district are being fed from charitable funds. In this region alone 20,000 miners are on strike, and the lack of coal has thrown out of work 60,000 potters, to whose number must be added thousands of general laborers, porters, railroad men and bargers, whose livelihood depends on the output of the potteries.

WYCLIFF A. COTTON OF DEWITT IS DEAD

FORMER STATE SENATOR FROM CLINTON COUNTY

He Is Stricken While Walking to a Lodge Meeting with a Friend

DEWITT, Ia., March 20.—Wycliff A. Cotton, formerly state senator from Clinton county and one of the prominent attorneys of this section of the state, died suddenly last night while on his way to attend the Masonic lodge meeting. He was walking down the street in company with J. Berman, a friend, when he complained of feeling weak. Mr Berman assisted him to a seat in front of Nonnemaker's furniture shop and later helped him inside the store. Dr. Lyon was summoned from the Masonic lodge rooms, but Mr Cotton died a few minutes after he had been taken ill. Heart disease is ascribed as the cause. He had an attack of heart trouble about Christmas time.

Mr Cotton was 69 years old, having been born Feb. 2, 1843. He had been practicing law in DeWitt for about 40 years. His wife died March 21, 1910. He leaves a daughter, Mrs Clella Culbertson, and a granddaughter, Mary Cotton Culbertson of Masailon, O., and a brother, Salem of DeWitt, and a sister, Mrs Tabitha Pascal, residing west of town.

Mr Cotton was a member of the Christian church most of his life time, and a member of Right Hand lodge, No. 281, A. F. and A. M., the Royal Arch chapter, and of the consistory and commandery of the Masonic order in Clinton. He was one of the oldest members of the Clinton County Bar association.
