## CAPT. WOLFE DEAD

L. R. Wolfe of Oxford Dies Suddenly at Selden, Kansas.

Was a Prominent Man in Iowa and Kansas, and for Many Years a Member of the Iowa Legislature—Remains will be Brought Back to Oxford.

Captain L. R. Wolfe, one of Johnson County's pioneers, and one of Iowa's leading men, died suddenly Wednesday at Selden, Kansas. He was past 80 years of age and heart disease was the cause of his death. The news came as a shock to his many friends in this locality. He resided at Oxford and the remains will be brought back there for interment. Capt. Wolfe was for many years a member of the Iowa legislature. His career has been an honorable and a successful one and he leaves a large estate.

An aged widow and three children survive him. The sons are Mahlon Wolfe of Summit street of this city and Douglas Wolfe of Greencastle, Iowa. Mrs. William Hardy of Oxford was his daughter. Captain Wolfe served in the civil war and has been a prominent figure in the state since that time. He was also well known throughout Kansas, where his banking interests were extensive, and he was there on business at the time of his death.

The remains will be brought to Oxford for interment.

The funeral will be held tomorrow morning at 10 o'clock at Oxford.

Fredonia No Longer a Point on the Rock Island System

The Rock Island System has abandoned the Fredonia station on the southwest division. This town came within one vote of getting the location of the state capital, at the time the seat of the state government was established at Iowa City. Fredonia is in Louisa county, Ia., and was laid out about the time the capital was removed from Burlington to Iowa City.

Fredonia was for many years a promising railroad center, one of the oldest stations on the Rock Island system, but of late years it has been outstripped by more promising rivals, and has gradually drifted backward, and during the past few months the trains of the company have not stopped there, as there was not sufficient business or traffic to warrant them doing so, and now the town no longer has a place on the map and time tables of the road. republican ticket in 1881. He defeated the regular democratic nominee, Daniel A. Shafer, by a very handsome majority, and thereby taught the convention organizers that they might nominate a man, but could not elect unless they got votes enough.

WILLIAM WOLFE, a farmer and stock dealer in Clear Creek township, post-office, Tiffin; was born in Knox county, Ohio, March 18, 1827; settled in Johnson county, Iowa, October 10, 1853, upon the farm where he now resides. He was married September 8, 1850, to Miss Hannah Colony, of Knox county, Ohio, and they have a family of six children: Alice E., John C., Milton L., Mary A., William B. and Charlie. The family attend religious services at the M. E. Church, at Tiffin. Mr. Wolfe has been shipping stock for fourteen years. His average shipment of hogs has been about one hundred cars per year; his average shipment of cattle about twenty cars per year. Hogs and corn have been the principal products of his farm. He has some very fine horses of the Clydesdale stock; he has a farm of 490 acres, 203 acres was his original claim. He was a member of the board of supervisors in 1860 and served three years; he filled the office of township trustee several terms. He is a democrat in politics. He is a brother of the Hon. L. R. Wolfe, representing Johnson county in the Iowa legislature. His father is living in Knox county, Ohio, at the ripe old age of ninety-two years and past.

HON. LEWIS R. WOLFE, farmer and stock dealer, post-office, Oxford; was born in Knox county, Ohio, April 22, 1825, where he lived until he was about twenty-four years of age, when he went to Hardin county, Ohio, and lived there five years and cleared up a farm. In September, 1854, he came to Johnson county and settled in North Bend, where he bought 306 acres of land and has since been engaged in farming and dealing in stock, and in April, 1876, he moved to Oxford township, to the "Iowa Valley Farm," where he now resides. He now owns 1400 acres of land in this county, laying in five different townships. In 1860 he was elected by Madison township as county supervisor, and in August, 1862, he enlisted in company I, Sixth Iowa cavalry as captain, and served as captain until April, 1865, when he resigned. In 1865 he ran on the democratic ticket for sheriff, but was defeated by John Wilson, and in 1866 was elected as supervisor for Madison township and served two years, and was elected by the county as supervisor. He was representative for the district in the eighteenth general assembly, and also the nineteenth, and still holds that office, and for several years has been treasurer of Oxford township school fund. He was married April 22, 1847, to Elizabeth Lindsley, of Richland county, Ohio, and has three children living, viz: Mahlon K., Christopher D., and Pheobe A., now Mrs. William Hardy.

#### HON. L. R. WOLFE.

MR. SPEAKER—Your committee, appointed to draft resolutions commemorating the life and public services of the Hon. L. R. Wolfe of Johnson county, respectfully submit the following report:

WHEREAS, The Hon. Louis R. Wolfe, an honored member of this House in the Eighteenth and Nineteenth General Assemblies, a gallant soldier of the Civil War and a most highly respected citizen in the county in which he resided, passed from his earthly labors on the 16th day of September, 1903;

WHEREAS, The life and character of the deceased were such as to entitle him to the respect and esteem of all who knew him, and his services to the State and nation were of such a character as to command the confidence and gratitude of his fellow citizens; therefore be it

*Resolved*, That in the death of this patriotic citizen, soldier and legislator, this State has lost an influential and upright citizen, his family is bereft of a kind and loving father, his friends of an honest and esteemed man.
