HON. L. D. HOTCHKISS DEAD.

Stricken With Heart Failure, He Passes Away After a few Hours Illness.

Loyal Hotchkiss is dead! Such was the sad news that circulated throughout the community last Sunday morning. But few knew of his illness. At three o'clock in the afternoon of Saturday he came into the Democrat office and wrote a letter, talked a few minutes, and started home, stopping on the way to pass the time of day with acquaintances. About five o'clock he reached the home of Rev. J. W. Bush and stoppeed to inquire about the health of a sick child. Here he became ill and started for his home, but became to ill to reach it, and stopped at the home of his son, W. M. Hotchkiss. Medical aid was summoned, but it was of no avail, and at eight o'clock he sank back upon his couch, closed his eyes as if in sleep, and passed away without a straggle.

The funeral occurred, Monday at the Methodist church. Rev. Robertson preached the funeral sermon, and warmly eulogized the upright christian character of the deceased. Senator Taylor and Col. Moore also spoke briefly of his life work and the old memories of his earlier life.

Loyal D. Hotchkiss was born in Portage county, Ohio, February 8, 1835. He was therefore 56 years, 8 months and 7 days old at the time of his death. In 1839 he moved to New Haven, Conn. He came to Davis county, in 1850 and made it his permanent residence.

In 1858 he was united in marriage to Miss Ellen Hotchkiss, and the same year became a member of the Methodist Episcopal church, and did much for that organization, as a minister and as a christian worker. He never wavered in the faith and when it was seen that he must pass away, and he was asked if all was well, he answered "O, yes, yes!"

In 1875 he was elected to represent Davis county in the legislature, was re-elected in 1877, 1885, 1887 and 1889. At the memorable session of the legislature of 1890, he was chosen Temporary Speaker of the house, which office he filled throughout the "dead lock" in an impartial manner which won him the respect and confidence of both friends and opponents, and at the last Democratic state convention his name was presented as a candidate for R. R. Commissioner, but another was selected.

A Resolution.

Resolved, that it is the sense of this Alliance that the county offices of Davis county should be run by the men elected to fill them without any deputy hire from the county, and that we will not support any man for a county office who will not pledge himself to run the office without deputy hire.

The above resolution was introduced at the county meeting of the Alliance in Bloomfield, last Saturday, by Wm. T. Dupree, the Republican ring candidate for the republican nomination for representative. From the reputation of Mr. Dupree we can hardly believe that he would introduce such a resolution with the hope of entrapping some democratic candidate into making a pledge that would disbar him from office if elected, and give the place to his republican opponent, but the indications would warrant the assertion that it was a piece of political trickery.

The call for the Democratic county convention, was published in the Democrat of July 23, and in that call the date of the Democratic primaries was stated and yet Mr. Dupree waited until that very day when the active Democratic members of the Alliance were at their primaries and when there was less than a score of members present, to introduce his resolution.

So much for the dates of that resolution. Now, let Mr. candidate-of-the-town-Ring Dupree acknowledge the trickery or state his innocence of law already on the statute book before he permits the Ring to put him up to make other laws.

A little more than a decade ago the democrats of Jasper county were like our Republican brethren of Davis county—they wanted the offices and were fool enough to try to bribe the voters of the county into giving them to them. A fool democrat offered to give the voters of the county \$1000. of his prospective salary to elect him. He got a majority of the votes, when his opponent contested the election, and the lower court and the republican supreme court ousted him.

That our readers may know just how it was done, we publish a part of the ruling of the court, (see Page 346 of the 53 Iowa reports) and a history of the case:

The appellee contests the election as appellant to the office of recorder of Jasper county. At the October election of 1878, the parties were candidates for the office of recorder of the county. The appellee received twenty-five hundred and twenty-three votes, and the appellant received twenty-six hundred and twenty-five, being a majority of one hundred and two. The appellee contests the election upon the ground that the appellant offered to the electors of the county, \$1000. as a bribe. The alleged offer of a bribe
