DEATH CAME ABOUT 10 O'CLOCK
WITHOUT A STRUGGLE.

An Old And Highly Respected Citizen
Who Will be Much Missed
From Our Midst

J. H. Carter, who for many years has been a highly respected resident of this city died at his home Saturday evening about 10 o'clock presumably from heart failure. 


The funeral was held from the late residence Tuesday afternoon at 2:00 o'clock, under the auspices of the Masonic lodge, of which order he was a valued member. Rev. Fitts of the Christian church officiating. Interment being had at the East Linn cemetery, besides the remains of his wife.

THE PILL ROLLERS IN GREAT DANGER

Boys Under 21 Who Smoke Coflin Nails Liable to Arrest Under Proudfoot Law.

The young men of the state who are under the age of 21 will, have to cut out smoking cigarets or liable themselves to arrest and imprisonment under the Proudfoot law which has received the signature of the governor and will become effective as soon as published.

The law says:

"It shall be unlawful," says the Proudfoot act, "for any person under 21 years of age to smoke or 'use a cigarette' or cigarettes on the premises of another or on any public road, street, alley or park or other land used for public purposes, or in any place of business or amusement, except when in company of his parent or guardian."

Under the new law boys under 21 years of age may be arrested for smoking cigarettes in almost any place except their own homes, unless accompanied by their guardians or parents. The bill was introduced by Senator Proudfoot by request, and the Iowa Anti-Saloon league intends to see it enforced.

J. H. Carter's Obituary.

Jackson Haywood Carter, the son of Andrew F. and Nancy Carter: was born in Bath County, Kentucky, Sept. 27, 1833 and was one of a family of seven boys three of whom are still living, two in Indiana and one in Missouri. After the death of his father, March 5, 1836, his mother moved to Indiana and settled in Morgan County where the life of the pioneer was anything but pleasant. There were no advantages for the young men of those days and nothing but hard and earnest endeavor lay before them in their efforts to provide food and raiment to keep body and soul together.



As time went on, Mr. Carter learned the blacksmith trade and for several years, divided his time between that of his trade and farming. He was successful in all his undertakings and succeeded in making his way, in spite of the many disadvantages of the pioneer he had to contend with. In the year 1854, on the 15th of January, he was united in marriage to Miss Mary Roberts, at Martinsville, Ind., where they made their home until 1862, when they came to Iowa and located at Wiscotta and set up a blacksmith shop, after a year's residence there, they moved to Redfield, and continued at his trade for about 13 years, then sold out and engaged in the hardware business and for several years conducted one of the leading establishments of the city.

In the year 1892 he was elected representative of Dallas Co. and served in the 24 and 25 general assembly. He was very popular among his colleagues and served on many important committees. He acted as doorkeeper of the senate and served as such at several sessions.

TRAIN HAD

CLOSE CALL

TRAILERS JUMP OUT FROM UNDER ENGINE

Accident Happened Milwaukee Passenger Tuesday Morning, East of Des Moines River Bridge.

Why the Milwaukee's west bound passenger train No. 1 was not wrecked near here Tuesday morning is one of the strangest mysteries that has been recorded in railroading. The train was pulled by one of the Atlantic type of engines, which had large trailing wheels attached just back of the drivers. While coming down the hill and when near the Des Moines river bridge on the east side, the trailing wheels left the track, broke loose from the engine and went tearing down the embankment. The compact of the heavy trucks against the ties tore the track up for several rods, but strange as it may seem not a car left the rails. The engineer applied the emergency brakes and brought the train to a stop just east of the bridge. A freight engine standing in Woodward yards was sent down and pulled the passenger train into Perry. The disabled engine was able to get to the Perry shops under its own steam. The accident delayed traffic for some time and six freight trains were tied up in Woodward at one time. How the trailers could get out from under the engine without wrecking the entire train is a mystery that the railroad men can not solve, and it is one of the queer accidents of railroad history.—Enterprise.
