# MR. EMMERTS FUNERAL

STATE OFFICIALS PRESENT AND  
PAY TRIBUTE

One of Largest Funerals Ever Held  
in the City—A Great Loss to  
Atlantic

"He was a good man."

The above sentence was the theme adopted by Dr. George, who presided at the funeral of Dr. J. M. Emmert. No higher tribute can be paid to any man than those few words. Those who have known Dr. Emmert know full well that he was the embodiment of all this phrase would mean.

The funeral services held at the beautiful Emmert home yesterday afternoon was one of the most widely attended of any ever held in this city. It was evidence of the love and respect our people, that of adjoining towns and counties and the state at large, held for this good man.

Early in the afternoon the people began to congregate at the house, which, although large, was sufficient to hold but a small number of those present. The large lawn was appropriated by the lodge and citizens. The services were opened by a scripture reading by Dr. Henderson followed by a prayer by Rev. Griffith. Following this Dr. George delivered the funeral sermon. He spoke of the life of the deceased, telling of his many good qualities and diverged from the regular to give some personal references to himself and the doctor. He told of a plan which few had ever known before, of a trip to the holy land and said that only last week had arrangements been made for staterooms and passage, the trip to be undertaken in 1910. He said that it was the desire of the doctor to go over the ground where his Saviour had trod. This of course will never be, for Doctor Emmert has now gone to his reward and is standing with his Saviour. For Doctor Em-
