and 366 cases. In the probate docket there are 167 cases, 63 new; law docket 15 cases, 3 new; chancery docket 114 cases, 39 new. Of the 39 new chancery cases 18 are foreclosures.

Eight wills are up for probate, the testators being Susan Nancy Allison, Sarah A. King, Margaret J. Polly, James B. McElwain, Martha M. Vincent, Mary C. Gordon, Charles A. Carter and Emma Smith. The last one is marked "with objections thereto." The Allison will above, it seems is fast on the docket and can't get loose. This is an old timer.

Of the 15 cases on the criminal docket one defendant is indicted on charge of plain larceny, 4 for larceny in the night time, 1 for wife desertion, 1 for bootlegging, 3 for manufacturing hooch, and three are held to the grand jury. Two of those held for making hooch are also charged with nuisance.

The following classification of other cases on the docket will indicate to our readers the scope of legal troubles that are brought to the court this term: There are 81 cases filed on notes, 34 on account, 32 final reports of executors, administrators, guardians, etc, 30 foreclosures, 29 partition, 21 damages, 14 attachment, 14 divorce—6 old and 8 new, 13 petition to sell real estate, 7 law, 7 to quit title, 6 petition for guardian, 6 injunction, 4 chancery, 3 replevin, 3 appeal from justice of peace, 3 separate maintenance, 3 appeal from assessment, 2 report of guardian—not final, 1 application for order, 2 on commission, 2 specific performance, 3 accounting, 2 certiorari, and one case in each of the following actions: Petition on claim, application for allowance, report of trustee, application for appraisal, application to sell bank stock, application for monument, appeal from record of fence review, one to set aside probate of will, equity partition, assignment, to reform note and mortgage, to sell mortgaged

Captain Elerick Passes Away.

Capt. James Elerick was born in Belmont county, Ohio, April 6, 1836, and died at Monrovia, Calif., Aug. 7, 1922, aged 86 years, 2 months and 1 day. He leaves one daughter, Mrs. Geo. Seimon, with whom he made his home since leaving Iowa; and one grandson James E. Seimon, who were with him during his last illness and death. They reside at Hinkley, Calif. His wife, who was Miss Maggie Short, preceded him April 1, 1835.

Capt. Elerick enlisted July 17, 1861, in Co. A, 59th Ill. Vol., and was promoted Captain of Co. A, 69th Ill. Vol., December, 1862. He had six brothers who served in the same war of 1861-65. Capt. Elerick participated in the battles of Pea Ridge, Siege of Corinth, Perryville, Ky., Stone River, Liberty Gap, Chickamauga, Look Out Mountain, Mission Ridge, Rocky Ford, Resaca, Burnt Hickory, Kenesaw, Rough Station, Jonesborough, Franklin, Nashville, and siege of Atlanta. He was discharged Dec. 25, 1865, having served 4 years, 5 months, 8 days in the war of the Rebellion.

He was a member of the house of representatives from Van Buren county, in the 19th General Assembly; Senator from Jefferson-Van Buren counties in the 30th, 31st, 32nd and 32nd extra Session. He also served two full terms as Sheriff of Van Buren county. He came to Iowa in 1849 and settled in Douds, Village township, Van Buren county, Iowa, where he made his home until a few years ago, when he went to California and made his home with his daughter. Capt. Elerick will be remembered as one of Van Buren county's most honored and prominent citizens by the older citizens, always true to word, upright in all his dealings and always commanding respect of all with whom he met. He lived a useful and active life. Funeral and interment were in California.
