Phone Propositions To Be Presented

Lincoln Mutual Telephone Co. stockholders are called for a special meeting to be held Monday, November 19, at the court room in Greenfield at 2 o'clock.

Several propositions concerning the future of the telephone company will be presented at this meeting by the directors. A committee composed of P. L. Bickford, W. A. Piper and J. R. Lischer were appointed by the directors to secure propositions which will be presented to the stockholders at this meeting.

At the annual meeting the proposition of the West Iowa Telephone Company for a reorganization of the Lincoln Mutual was laid upon the table by a vote of the stockholders.

It is the intention of the directors to have several propositions to submit to the stockholders at the special meeting to be held here November 19.

The town of Stuart votes today on renewing the Lincoln Mutual franchise in the town for 20 years. The outcome of this vote will determine whether or not the Lincoln Mutual will be permitted to continue to operate in Stuart.

New Upholstered Seats For Grand

New upholstered seats for the New Grand Theater here, are expected in the near future, according to L. A. Kuhl. A representative of the Haywood-Wakefield Company was in Greenfield a week ago making a survey of the theater auditorium and adapting the seats to the pitch of the floor and the space to be seated.

The new seats will be upholstered in mohair both back and seat and will involve an expenditure of \$5,000 or \$9.50 per seat. The upholstering will be coral in color.

OVER QUOTAS

Bridgewater, Grove Get Flags

Twelve towns and townships have gone over their quotas in the Victory Loan drive.

The two paratrooper flags were awarded Fern Gipple of Bridgewater with a 200 per cent sign-up as of November 7; and to Art Sackett, chairman of Grove township with a sign-up of 132 per cent.

Towns and townships over their quota in the sign-up campaign in order in which they reported are: Walnut, Fontanelle, Harrison, Greenfield, Orient, Grand River, Bridgewater, Orient twp., Richland, Prussia, Eureka, Adair.

Of the towns Bridgewater led in exceeding their quota 200 per cent, Fontanelle 151 per cent, Orient 144 per cent, Greenfield 143 per cent, Adair 104 per cent.

Although over their quotas towns and townships are still continuing to receive sign-up pledges.

Victory loan bond buyers are urged to buy their bonds as soon as possible. It is the actual sale of bonds which determine whether Adair county meets its quota. The sign-up drive is only preliminary to the actual buying of bonds.

Dr. R. H. Gregory, 75 Dies Wednesday

Dr. R. H. Gregory, 75, mayor of Fontanelle, and widely known Adair county resident, died at his home in Fontanelle Wednesday morning at 2:30 o'clock. Dr. Gregory suffered a cerebral hemorrhage a week ago which paralyzed his left side and had been in a critical condition since.

He began the practice of medicine in Nevinville and upon retiring from active practice, made his home in Fontanelle. He served in World War I and was the oldest Legionnaire in Iowa.

He is survived by his wife, a son, Dr. Francis Gregory, LaJolla, Calif.; a daughter, Mrs. I. M. Redeker, Palo Alto, Calif.; and stepsons, David L. Griffin, Long Island, N. Y.; A. I. Griffin, Greenfield; and stepdaughter, Mrs. D. J. Silsby, Mt. Vernon, Mo.

Funeral services will be held Thursday afternoon at 2 o'clock at the Gregory home in Fontanelle. Burial will take place at the Avondale cemetery.

The proposition on which voters cast their ballots in the special election was the issuance of \$100,000 in bonds to pay the cost of establishing, erecting and equipping a county hospital and procuring a site therefor. To pay the said bonds and interest, a 1/2 mill levy on the taxable property of the county was voted.

The location, construction, and operation of the county hospital will be the responsibility of a board of seven trustees to be appointed by the board of supervisors. The trustees, not more than four of whom shall be residents of the town in which the hospital is located, will serve until the next general election when they will be elected by the voters. Three members of the hospital board of trustees may be women. None of the board of trustees can be a physician.

Adair County Corn Tests Run High

Adair county farmers are again reminded by J. N. Chicken, county extension director, to delay cribbing corn until the moisture has been reduced enough to insure its keeping.

Tests made of samples of corn in the county show that the moisture is running from 20 to 35 per cent, which would indicate that much of the corn crop is still not safe for permanent storage.

Unless the test shows less than 20 per cent moisture, the corn will not dry out enough this winter to prevent possible damage next spring.

Corn to be fed before spring probably can be stored if the moisture is between 20 and 30 percent, provided the cribs are well ventilated.

When moisture is over 30 per cent spoilage may occur even during the winter months.

Farmers who wish to have moisture tests run may take them to their local elevator or to the AAA office.

In taking a sample, corn from a large number of ears should be mixed together. Shelling two rows of kernels from each ear with a screw driver forced the length of the cob makes quick work of the sampling job. As soon as the corn is shelled it should be sealed in a fully filled tight container—a pint mason jar is satisfactory.

Funeral Services for Dr. R. H. Gregory

Funeral services were held on Thursday, November 8th in Fontanelle for Dr. R. H. Gregory, who died at 2 a.m. on November 7th, 1948. Dr. Gregory had been confined to his bed a little more than a week following a severe heart attack. He had been in failing health for some time, but kept active right to the last. He was in his 76th year. Funeral services were held in the large residence in Fontanelle and were conducted by Rev. A. J. Goodson, pastor of the Congregational Church. Brief tributes were paid to the memory of Dr. Gregory by Pastors S. E. Wright and O. W. Lauxmann, former pastors here; also pastor A. J. Seegers of the local Lutheran Church, and Judge Johnson of Creston. Mr. Arthur Brown sang "Rock of Ages" accompanied by Mr. Henry Stuhlmiller at the piano.

Dr. Gregory was a long time member of the official board of the Congregational church. He had also previously served one term as Mayor and was in that position at the time of his death. He was always quite interested and active in all community enterprises.
