# DEATH SUMMONS DR. J. A. DEARMAND, PIONEER DOCTOR

## Prominent Politician and Public Servant Dies of Arterial Sclerosis

In the death of Dr. J. A. DeArmand Friday evening from arterial sclerosis Davenport has lost one of its pioneer physicians, a public servant with a long and unblemished record and a politician with a wide acquaintance in Davenport and in Iowa.


On Christmas day Dr. De Armand was taken sick while at the dinner table. He went to bed and his condition soon became so critical that his physician's skill told him he had but a short time to live. He calmly wrote detailed instructions on the care of his body after death, the funeral and burial.

The deceased expressed the wish that no flowers be sent, that his body be incinerated, that the body be removed to the undertaking parlors as soon after death as possible, and that no one should view the remains. What undertaker should be employed and who the pallbearers should be was also specified. The family has observed to the letter this last request.

Dr. DeArmand had been in poor health for over a year. In February of 1916 he was taken sick and has never since then been in good health. Even while sick and confined to his bed he continued to minister to several patients, diagnosing their ailments and prescribing treatment.

In addition to practicing in Davenport for over 27 years and in LeClaire for 13 years Dr. De Armand held one of the governing reins in the Democratic party for many years and also
