## EFFORT TO GET BIG LEAGUE TEAMS TO WIPE OUT DEFICIT

The Commercial club has opened negotiations for a ball game between the All-Nationals and All-Americans, two all star clubs of the major leagues. The two teams were thought to have an open date between their St. Paul and Sioux City appearances and the Commercial club has been trying to get them here to help clear up the baseball deficit of about \$1,500.

Some of the big guns in the baseball world who are with the two teams are Forest Cady, catcher, and Dick Hoblitzel, first baseman with the world championship Boston Red Sox. Grover Cleveland Alexander and Bancroft, shortstop for the Phillies, are on the National club.

The two clubs will gather in Chicago today and Tuesday and go to Oskosh, Wis., for a game Wednesday. Thursday they play in Minneapolis, Friday in St. Paul and Saturday in Sioux City. They then go to Omaha and Grand Rapids, Neb.

If the press dope is straight, Fort Dodge, as may be seen, stands but little chance to get the two clubs. Floyd Douglas, secretary of the Commercial club has sent a letter to Mike Kelley, manager of the St. Paul club, asking what guarantee will be required.

The teams will line up as follows:

American Leaguers—Klepfer, Ayres, James and Harper, pitchers; Henry and Cady, catchers; Hoblitzel, first base; Mullen, second base; Schang, third base; Shanks, shortstop; Pipp, utility; Walker, Roth and Strunk, outfielders.

## JOHN W. CAMPBELL, PROMINENT BANKER, CALLED FROM LIFE

CASHIER OF COMMERCIAL NATIONAL BANK SUCCEDES TO GENERAL BREAKDOWN

HE HELD PUBLIC OFFICES

SERVED AS COUNTY AUDITOR AND TREASURER AND WAS STATE REPRESENTATIVE

John Wesley Campbell, cashier of the Commercial National Bank of Fort Dodge, died at his home on north Ninth street Sunday evening at 11:30. Death came to him when he was sixty three years of age, and was the result of a general breakdown from which he has been suffering for the last two years.

Just a week ago his condition was thought to be serious and his son W. Raymond Campbell who was at Colfax for his health, and his daughter, Mrs. Almond Cochran of Okmulgee, Oklahoma, were summoned.

The news of his passing will be a distinct shock to the community as Mr. Campbell, through will power and a tendency to minimize the seriousness of his condition, was regularly at the bank and on the street until a week ago.

However, he has been relieved for some time past of the arduous responsibility of his position by his son who has been acting cashier.

### At Desk Since 1891

Mr. Campbell was made cashier of the Commercial National Bank when it was organized in 1891 by influential Fort Dodge men, all now deceased. They were Isaac Garmoe, O. H. Norton, S. J. Bennett and J. Kirchner. Previous to taking this position he had been cashier of the First National Bank for a short time.


## City Hall Furnishing Bids Opened Tuesday

Mr Campbell's influence politically extended beyond the confines of the county. He was elected state representative in 1911 and served during the Thirty Fourth General Assembly. It was this assembly that elected Wm. S. Kenyon senator and Mr. Campbell was indefatigable and influential in his election.

### Born in Wisconsin

Green County, Wisconsin, was the birthplace of J. W. Campbell. He was one of a family of six children. In 1876 he came to Iowa and was married at Dayton to Miss Hattie Leonard. After a short residence there the family moved to Lake City where Mr Campbell taught school. They returned to Gowrie to live some time and it was then that he was made deputy treasurer under Arah Leonard, Campbell's uncle.

It was because of this appointment that the family came to Fort Dodge to live. This city has since been their place of residence. During the years Mr. Campbell has lived a quiet and unostentatious kind of life, attending to his duties wherever they were and endearing himself to a large number of people. Especially bereaved at this time, aside from the family, are friends, unknown to the world in general, who experienced his friendship and assistance, financially and through the power of his genial nature. Mr. Campbell was a man of original and impulsive charities and kindnesses. He liked to be a friend to man, his inspiration in this direction rising not from love of adulation and publicity, but from heart impulse.

Mr. Campbell will be missed also in lodge circles. He was a member of the Masons, Odd Fellows, Royal Arcanum and Elks. For many years he has been treasurer of the Odd Fellows Lodge.

### Relatives Living

Besides his wife, son and daughter he leaves two brothers and two sisters. They are Robert Campbell of Clayton, Idaho, Will Campbell of Rolfe, Mrs. Edgar Wilcox of Rolfe and Mrs. William Swan of Albany, Wisconsin. Until these relatives are heard from no arrangements for the funeral will be made.
