Passing Of L. E. Crist Being Mourned By Entire County

Funeral For Well Known Attorney To Be Held From Funeral Home Friday At 2:30 p. m.; Long Life of Service.

LeMerton E. Crist for more than 40 years a practicing attorney in Osceola, and one of the most prominent citizens in Southern Iowa died in a local hospital, Tuesday afternoon. Death came as a severe shock, not only to members of the family, but to all his personal friends and acquaintances. He had been in failing health for several years and at different times during the past year or two sought the hospital for rest and recuperation. It was known that his strength was failing gradually but the end was sudden, the result of a weakened heart and pneumonia which had developed a few days before the end.

Funeral services will be held from the Webster Funeral Home, Friday afternoon, May 4, at 2:30 o'clock. Rev. W. M. Brooks will deliver the sermon. Interment will be made in Maple Hill cemetery.

Some men live to a ripe old age and fail to leave to posterity anything of real value or worthy of emulation. Others survive but a comparatively few years and leave as a monument of their earthly endeavors the splendid fruits of untiring energy, unselfishness, self abnegation, and loyalty to family, friends and community, a challenge to future generations, a monument more durable than a marble shaft even though it reach the sky. Mr. Crist left a heritage of good deeds, of constructive community and state service that stamped him as a man of unusual and strong character.

The deceased was born on a farm near Hebron, Clarke county, July 7, 1872 and was nearing his sixty-third birthday when death came. He was the son of George A. and Hannah Clark Crist, sturdy pioneers who came to Iowa in 1840, showing the clouds of the Civil war.

He grew to young manhood

unflinching energy. At the bar he was courteous and pleasant but at all times insisted upon his client having his full rights under the law.

One's habits and hobbies, if they be known, vision like a mirror the character of the individual. Mr. Crist was a great lover of flowers and shrubs. The beauty of the rose and the lily, like excellence in the individual, appealed to him. Even though strength was failing, he found rest, recuperation, invigoration and surcease from the daily problems of clients, in the garden. He admired and found pleasure with friends in the results of his labors.

The body was taken from the hospital to the home, Thursday, there to rest until the funeral services. It was the home he had built when a young man more than a quarter of a century ago. It was the place where he enjoyed to the fullest the companionship of the wife and two sons until the latter grew to manhood and departed to make a place for themselves. It was the home where in that quiet and beautiful marital bliss he dreamed and planned for the future, the day when he might lay aside most of the earthly labors, cares and worries for the evening in life when contentment reigns supreme. To the hour of his passing he looked forward to the June day when all the family might gather in another of those annual reunions.

The deceased was for many years a member of the M. E. church and before failing health denied him the privilege and pleasure of giving time and labor on the church board his services and advice were sought and freely extended.

Tallman in Osceola, was admitted to practice and "hung out his shingle" in Osceola a little more than forty years ago. All his active and professional life was spent in this city, just a few miles from the hills and valleys where nestled the pioneer home of his parents, who long since passed to their reward.

Mr. Crist early in life took an active interest in politics and especially in the problems that confronted the town and county in which he lived. As a young man he served four years as city attorney of Osceola and four years as mayor. His administrations were marked by most excellent service, and an environment of civic and social progress.

Solicited by many friends and admirers to make the race on the Republican ticket in 1910 for representative to the General Assembly he acquiesced and was successful. Two years later he was nominated for senator in the district composed of Clarke and Warren counties and served during the sessions of 1913 and 1915 in that body. His record as a legislator was outstanding. Possessed of a clear, analytical mind, a close student of all proposed legislation, he became a leader. As a mark of confidence he was elected president pro tem of the senate, a position which carried great party responsibility.

After six years of service to the state Mr. Crist voluntarily retired, came home and gave his attention ever afterwards to the practice of his profession. As a lawyer he had few equals and no superiors. Never strong phys-

Selected as outstanding students, they were chosen by the college and the Veishea Central Committee to be specially invited to attend the Veishea celebration in Ames on these three days. Veishea, an all-college celebration, includes sports, exhibits, carnivals, social activities and plays given chiefly for outside visitors.

Passed Away Tuesday At Local Hospital After Long Illness

Funeral services for L. E. Crist, 61, well known and highly respected Osceola attorney, were held Friday, May 4. Death came to relieve his suffering Tuesday, May 1, after an illness of several days at a local hospital following a heart attack.

Services were conducted from the Webster Funeral Home by Rev. W. M. Brooks and interment was made in Maple Hill cemetery.

Always interested in the affairs of his community, he gave of his time and talents to its betterment. He served four years as city attorney and four years as mayor while still a young man. In 1910 he was elected to the house of representatives in the Iowa General Assembly and two years later he was elected to the state senate, serving two terms there.

LeMerton Edson Crist, son of Geo. A. and Hannah Clark Crist, was born in Clarke county, Iowa, July 7, 1872, departed this life in Osceola, Iowa, May 1, 1934, having attained the age of 61 years, 9 months and 24 days. He was educated in the public schools, and later took up the study of law in the office of Attorney W. B. Tallman. He began the practice of law in Osceola in the year 1896. His whole life was spent in Clarke county, and his professional life in the city of Osceola.

He was united in marriage to Miss Cora Pritchett in Osceola, October 28, 1897. Two sons were born to Mr. and Mrs. Crist: LeMerton Edson, Jr., and Bird Pritchett.

The ZEPHYR has only sixteen wheels altogether (a train having three cars of conventional equipment would have thirty-six) and the weight of one car and the engine is the succeeding one resting on the same truck—the herald-articulated method, which not only makes for economy and light weight, but also for smoother running qualities, less noise, and less vibration (the sometimes unpleasant jerk due to “slack” between the cars of an ordinary train).

The ZEPHYR is driven by electric power generated by an eight cylinder, 600 horse power, two-cylinder Diesel engine that uses heavy oil as fuel. Without spark plugs or ignition system of the type used in gas engines, combustion is accomplished wholly through compression. It is freely predicted that the motorized trains of the future will be powered by Burlington-type Diesel.

But articulated trucks and electric motive power are only two of many of the new features incorporated in the Zephyr's construction. Structural material is practically all 18-8 stainless steel alloy consisting of 18 per cent chromium and 8 per cent nickel, cold-rolled, and characterized by its light weight, great strength, high tensile strength, resistance to fatigue, and its non-corrosive qualities which render painting unnecessary. The entire train weighs 90 tons which is about equal to the weight of a Pullman car.

The insulation between exterior and interior sheathing is a special foil almost as thin as tissue paper. Slightly crumpled before being placed in position, its surface is characterized by tiny angular and irregular-shaped facets, and heat insulation is accomplished by reflection. Only 100 pounds of this material were required to insulate the entire train.

All passenger compartments of the train are air-conditioned; windows sealed; temperature automatically controlled. The air brake equipment in-

cludes a device which controls the rate of retardation to prevent sliding wheels, and has a maximum braking effort of 200 per cent of the light weight.

The shape of the ZEPHYR with respect to air-impact surface which accounts for the “drag” (that steals up to 75 per cent of the energy produced by a train's power plant in accelerating ratio as the speed increases), takes advantage of untold experiment and the most modern application of scientific streamlining in which the contour of the front and rear ends, the design of the wheel guards, the concave fluted sheathing of the sides, top and under surfaces, absence of rivet heads and flush window frames, are factors of self-evident importance.

The Burlington ZEPHYR (West Wind) was built at Philadelphia with the eminent Paul Oret who designed the Hall of Science at the World's Fair, as consulting architect for the builders in charge of the interior design and decorative treatment, while the famed Chicago builders, Holabird & Root acted as consulting architects for the Burlington in the train's styling.

The train is scheduled for a two-month exhibition tour involving the principal cities from coast to coast, after which it will be exhibited throughout the summer at the Century of Progress Exposition in Chicago before going into active service between Kansas City, Omaha and Lincoln where it will replace existing steam service with much faster schedules at a lower operating cost.
