**JOSEPH MATTES DEAD**

Joseph Mattes is dead. His sun went down shortly after noon on Friday, April 17, and it sank amid the prophetic splendor of an eternal dawn. In the maturity of his powers, with unmeasured opportunities for achievement yet before him, with great designs unaccomplished, the pallid messenger with the inverted torch beckoned him to depart.

In the long struggle against the advances of an insidious and mortal malady, he did not falter nor repine. With more than a hero's courage, with more than a martyr's fortitude he waited the approach of the inevitable hour and went to that undiscovered country from whose borne no traveler returns.

In this solemn hour all the kindly adjectives that might be used to pay fitting tribute to the life and achievement of Mr. Mattes become inadequate and no blaze born in all our eulogy can burn beside the sunlight of his useful life. Odebolt has lost a useful man, one who was honored because he was a true servant of mankind.

While it was quite generally known that he was in a critical condition and his death was expected, it nevertheless caused a deep sense of loss to settle over the town and county when it became known that he was dead and that his influence would no longer be directly felt in business circles and civic welfare.

Funeral services were held Sunday afternoon at 2:30 o'clock from the First Presbyterian church, conducted by the Rev. A. E. Abben. The Masonic fraternity of which Mr. Mattes was a member attended in a body, the members of the local lodge being greatly augmented by visiting Masons from surrounding towns.

Members of the Odebolt Fire company attended in a body. They wore black ribbon badges in memory of Mr. Mattes, who was a charter member of the company and assisted in its organization. He took great interest in the company and its affairs and for many years was chief.

The Modern Woodmen and the order of the Eastern Star also were present.

The church was more than filled with those who wished by their presence to testify to the esteem felt for this pioneer merchant and banker. Many were unable to gain admission into the church.

Never were more beautiful floral tributes seen in Odebolt, nor as great

The Chronicle feels that it can not improve on the words read by the Rev. Mr. Abben at the funeral service, in bringing to its readers the life and character of Mr. Mattes:

"Joseph Mattes first saw the light of day at Camanche, Iowa, located in the beautiful Mississippi river section in the eastern part of the state, on October 1, 1855. When a lad of three years of age he moved with his parents to Lyons. Here he attended the public schools and later the Clinton high school.

"During his high school days he became interested in the hardware business and spent a year with a large wholesale hardware concern in Clinton.

"In January, 1879, he left the eastern part of the State for the newly settled, fertile stretches of western Iowa, which called so many of the more ambitious and energetic of the young men of the East to help in the making of the new country. He settled at Odebolt, where he became interested in a small hardware and tin shop, and where he remained all his life, an active leader in the building up of the community life, devoting himself wholeheartedly and unsparingly to the development of the new country which was to be home to him for the best part of his life.

In May of the same year he returned to Lyons and brought back with him his bride, who was Miss Catherine Elizabeth Shelly of Lyons.

Four children came to bless their home—Grace, Howard, Harriet and George, of whom three survive, Harriet having passed away in early childhood.

"The little hardware concern became a prosperous and well-developed business under the capable management and hard work of Mr. Mattes. His keen business judgment broadened out into other avenues of commerce and his influence became noticeably felt in this part of the state.

"In 1902 Mr. Mattes entered the State legislature as representative, serving two terms. Upon the expiration of his second term he was elected to the senate and served two four-year terms.

"His wisdom, experience and integrity brought him respect and recognition and last year, when Governor Kendall was searching the State for important men, competent to serve on the important budget board of the state, Mr. Mattes was selected as one of the three members and held this position until the day of his death.

who had with efficient hands and a brave heart, helped to make the home in the new country and bring prosperity and beauty to the naked prairie, passed away.

Mr. Mattes retained his active interest in the hardware business until 1915, when he was succeeded by his son George.

"Early in the history of the First National bank, Mr. Mattes became connected with its affairs and in the year 1907 was elected president, a position which he held until he died. This position Mr. Mattes invested with unusual dignity and honor, and through it served his community in a way long to be remembered. If ever it was true that the position does not make the man, but the man makes the

position, it was true in this case.

"Mr. Mattes not only had convictions, but had the courage of his convictions. If, after careful thought and due consideration, an action seemed right and necessary, no obstacles were deemed too difficult to surmount. Genuine courage is a rare virtue and when combined with integrity and sincere motives of goodwill and desire for service, is an invaluable asset. It was one of the characteristics which made his services so outstanding and unusual, and of such peculiar value.

"Mr. Mattes was also one of the founders of the Kiron State bank. He was intimately connected with it throughout its existence, served as vice-president a number of years, and just recently was elected to the presidency.

He was a director of the Iowa Mutual Hardware Insurance association for a number of years and acted as vice-president for the last fifteen years. He was prominent in all its activities.

"On September 3, 1914, Mr. Mattes was united in marriage to Miss Elizabeth Platt of Des Moines, and the reestablished home became anew a center of happiness and worth and service in the community.

"Mr. Mattes, up to the time of his death, was intimately connected with the affairs of the town. He was one of the organizers of the efficient Firemen's association, and served many years as an active member. He was interested in the founding of the city library, served a number of years on the school board, and many years as the chairman of the board of Trustees of the Presbyterian church.

"When the old church burned down he was made chairman of the building committee, and with great devotion and sacrifice helped to make possible the beautiful building now standing.
