Death came suddenly and was due to heart disease. Mr. Tucker had been in the employ of the Advertiser since his youth and he was one of the veteran and most highly esteemed employees of the newspaper. He had finished his daily work as usual and when he left early this afternoon seemed to be in excellent health.

TWO KILLED AS CAR PLUNGES OVER BRIDGE

Des Moines, Sept. 17.—Harry W. Loyer, a contractor, and his wife, were killed last night when their automobile plunged through the railing of the Sixth avenue bridge across the Des Moines river, and fell 40 feet to the river bank. Both occupants of the machine were crushed, the car having turned over as it fell.

Persons who witnessed the accident said the car skidded on the slippery pavement but that it appeared the driver put on more power just before it climbed the sidewalk and tore through the railing.

Another car was struck by the Loyer machine before it left the bridge. Loyer was prominent in business and lodge affairs and Mrs. Loyer was widely known in Des Moines society.

They were returning from Cedar Falls where they had visited with Loyer's brother, when the accident occurred.

BUSY MORNING FOR COURT

A large number of defendants were arraigned this morning in municipal court as the result of arrests made Saturday and Sunday by the Clinton police department and county officers.

John Daasch, arrested on a charge of seduction, waived a preliminary examination and was held to the Clinton county district court under \$2,000 bonds.

Alfred Johnson waived a preliminary examination on a charge of forgery and was held to the Clinton county district court under \$500 bonds.

Harold Hardsone and Benjamin Proost will have preliminary examinations on charges of maintaining a nuisance tomorrow morning at 9 o'clock in municipal court.

A. T. Hendricksen was held to the Clinton county district court under \$500 bonds on a charge of driving an automobile while he was intoxicated.

W. E. Hall and Edward J. Stanton, both arrested on charges of vagrancy, were fined \$10 and costs each and C. R. Dolan, charged with the same offense, pleaded not guilty and will have trial tomorrow morning at 9 o'clock.

Frank Nelson was fined \$10 for automobile speeding and also sentenced to four hours' imprisonment in the Clinton county jail. He served the sentence today.

Six defendants were sentenced to pay fines of \$5 and costs on charges of intoxication this morning in municipal court, two were fined \$10 and costs another was sentenced to 15 days in the county jail.

R. E. Lee pleaded not guilty to a charge of automobile speeding and was held to the Clinton county district court for trial tomorrow afternoon.

William Padden was sentenced to five days' imprisonment in the county jail for vagrancy.

DEATH COMES SUDDENLY TO G. F. TUCKER

George F. Tucker, prominent resident of this city, former state representative from Clinton county to general assembly, city councilman and holder of other public offices, died very suddenly at 7:45 o'clock at his home, 722 Randolph street. His sudden demise followed a heart attack suffered earlier in day.

George Tucker was 55 years of age, born in Princeton, Green Lake county, Wisconsin, July 16, 1865, of Scotch-Irish descent. He was educated in the rural schools of Dodge county, Minnesota, and the graded schools of Princeton, Wisconsin. He served his apprenticeship at the printer's trade at The Republic office at Princeton, Wisconsin, and later followed that occupation in Chicago and other large cities of the country. He came to Iowa in 1897 and on May 6, 1900, was united in marriage with Miss Laura Hollis at Mt. Pleasant.

From Mt. Pleasant he came to Clinton where he entered the employ of The Clinton Herald as a compositor. He and Frank D. Throop, now publisher of the Davenport Democrat, entered The Herald employ at the same time remaining for several years, and also continuing as staunch friends since Mr. Throop went from Clinton.

Mr. Tucker had always taken an active interest in the welfare of the city. Politically he was a Republican and served very acceptably as state representative from Clinton county to the 36th and 37th general assembly. He was twice elected to the city council and also served on the exemption board. He was a delegate to the Tri-City Labor Congress from Typographical Union, No. 334 for the past 22 years, and during that time rarely missed attending a session, unless he was out of the city. In all offices of public trust he had been found most faithful in the discharge of his duty. Fraternally he was a member of Pioneer camp, No. 1, Modern Woodmen of America and of Typographical Union No. 334, for 32 years.

Besides the bereaved widow he is survived by five children, Naomi, Philo, Richmond, Beryl and June, and one brother, Fred L. Tucker of Walnut, Ill.

Funeral services will be held Wednesday afternoon at 2:30 o'clock at Grace Episcopal church. The Rev. W. Ernest Stockley, rector, will officiate. Burial will be Oakland cemetery.

Members of the Typographical Union will attend the services in a body.

Friends who wish to view the body a rerequested to call at the home as the casket will not be opened in the church.

Yesterday afternoon the Tri-City Labor Congress held a special meeting at which it was decided to attend the funeral services in a body. This will be done so far as men may find it possible to leave

head. The boys, awakened by the shooting, took the weapon from their father's hand just as he fell to the floor dead. They notified neighbors, who summoned officers. Officers said they believed Kelly had been despondent and jealous.

Cedar Rapids, Sept. 17.—John Kelly Jr., who killed his wife and himself at Ventura, Calif., Saturday night, was a son of John Kelly Sr., wealthy farmer living in the Fairfax, Iowa, neighborhood. Four years ago he was in a thrashing machine accident in which he suffered a compound fracture of the skull and he had suffered a great deal of pain since. His brothers say his home life was ideal. His wife was formerly Miss Trophie Weinkle, known as one of the most beautiful girls in Linn county. Young Kelly was here four weeks ago and was in good health then. He had just completed the purchase of a farm in California. He still owned a farm in this county.

LET CONTRACT FOR SALVAGING

Los Angeles, Sept. 17.—The navy department has awarded a contract for salvaging the U. S. S. Chauncey, the only one of seven wrecked destroyers deemed worth floating, to San Francisco interests.

The machinery and equipment of the other wrecked vessels will be salvaged under direction of the navy. Captain "Midnight" Olsen, famous in the Pacific for his salvage work, left Los Angeles harbor aboard the tug Homer for Honda yesterday.

Chief Gunner John Harder, United States navy, said to be the navy's greatest deep sea diver, has been assigned to duty at the wreck. Operations are to begin soon.

NORTH END ONLY SECTION NOT OPENED

The north end section of new paving at DeWitt is now the only street, recently paved there to be closed to traffic, the others having been opened within the past few days. The north section will be opened within the next few days, according to Resident Engineer P. W. Shive of the Iowa state highway commission.

Back filling work is in progress at the Wapsie river under the supervision of the state highway commission but work on the new Wapsie river bridge is still held up due to the delay in receipt of steel work needed in the structural part of the bridge. The piers have been completed for several weeks.

Good progress is shown on grading of primary road No. 20 known as the Delmar road and running from the county line for two miles south.

Paving of the Ridge road between Lyons and the O'Far-Mile house is advancing slowly. There still remains one and two-thirds miles of the paving to be laid. The Layton Construction Co. has experienced some difficulty in getting trucks needed.

Grading of the Ridge road from Goose Lake to Charlotte will be taken up by the contractors about the middle of next week. Work will be commenced at the west city line with an outfit working in either direction.

Bridge gangs were expected to start work tomorrow. The Clinton Engineering Co. and John Kane of Charlotte have the contracts for the bridge work.

Tilling work was begun last Friday at Goose Lake.

GRAND JURY MEETS TODAY

The September grand jury for the Clinton county district court reconvened this morning at the court house. It was expected that the jury might return several indictments late this afternoon or some time tomorrow in a partial report to the court.

Judge W. W. Scott of Davenport came to Clinton today and presided in court. Arguments in the case of Gruber vs. Fay were heard. The plaintiff seeks to quiet title to certain real estate purchased from Minnie O. Fay as executrix of the estate of the late C. A. Fay, deceased and included in the estate. The judge has taken the case under advisement.


