before final determination as to the conditions under which the bank may be licensed to operate unrestrictedly, that the depositors be represented by a committee and the appointment of such a committee is the purpose of this meeting.

Under the department's regula- tions, the conservator is prohibited from paying even necessary expenses of such a committee and undoubtedly, at least, one trip to Chicago must be made by a such a committee. The bank, if ultimately licensed, very like- ly would consent to reimburse the committee for expenses advanced, but that, of course, is problematical.

Deplores Government Delay.

Mr. Everest also pointed out that the delay in getting action either on reorganization or authority to pay is not the fault of the bank of- ficials, but is due to the system under which they are compelled to operate. In this connection he said that depositors in closed banks all over the country are becoming much exercised over present condi- tions and are demanding that something be done. He read a let- ter from the president of the North City Trust company of Philadei- phia in which he urged that deposi- tors in all closed banks organize and send representatives to a meet- ing to be held in Washington June 10 for the purpose of protesting against the delay. He said they wanted the restricted banks opened 100 per cent immediately and de- positors in closed banks paid off 60 per cent. A. Mitchell Palmer, former attorney general of the United States, is to be counsel for the committee which meets in Washington.

It is expected that another meet- ing of depositors will be held here as soon as the committee returns from Chicago.

L. J. NEFF, WALNUT ATTORNEY, IS DEAD

FORMER STATE REPRESENTATIVE SUCCEUMBS AFTER OPERATION.

The body of L. J. Neff, 64, at- torney, was returned to this city Thursday for burial. Mr. Neff, a life-long resident of Walnut, died in an Omaha hospital after a major operation.

He was in republican politics and served two terms as state repre- sentative. He was past grand master of the Odd Fellows.

He is survived by his widow, Ruth Neff, living at Walnut.

J. Dugan removed to Woodbine, Harrison County, where he was established in practice until 1915, when he returned to Perry and resumed his law partnership with his brother, this alliance, as before noted, having been terminated by the election of his brother to the office of judge of the District Court. Mr. Dugan now controls a substantial and important general law practice of individual order and maintains his offices in the Brice & McLaughlin Building.

That Mr. Dugan has had much of influence and leadership in the Iowa councils and campaign activities of the Democratic party is evidenced in that he was, in 1929, chairman of the State Democratic Central Committee of the Seventh Congressional District. He was a delegate to the Democratic National Convention of 1928, at Houston, Texas, and his professional activities at Perry have included his service as city solicitor and assistant county attorney. He is affiliated with both York and Scottish Rite bodies of the Masonic fraternity, besides being a Noble of the Mystic Shrine, and is a past exalted ruler of Perry Lodge, B. P. O. Elks. He and his wife have membership in the Methodist Episcopal Church.

September 9, 1908, recorded the marriage of Mr. Dugan to Miss Emma Harned, of Grand Junction, Greene County, where she was graduated in the high school, she having thereafter pursued a thorough course in the musical department of Drake University, Des Moines. Doris, only child of Mr. and Mrs. Dugan, was born at Woodbine, this state, May 10, 1914, and is a student in the high school in her home City of Perry.

Mr. Dugan is an influential and popular member of the Dallas County Bar Association and has membership also in the Iowa State Bar Association and the American Bar Association.

LEWIS J. NEFF has been engaged in the practice of law at Walnut, Pottawattamie County, during a period of more than a quarter of a century, and the scope and importance of his law business indicate the high popular estimate placed upon him as citizen and well fortified lawyer.

Mr. Neff was born in Livingston County, Illinois, September 21, 1868, and is a son of John H. and Phebe (Crow) Neff. His paternal grandfather, Samuel Neff, was born in Ohio, and his maternal grandfather, John Crow, was a native of Pennsylvania, where he became a coal miner, but eventually removed to Illinois, where he engaged in farm enterprise and where he passed the remainder of his life.

John H. Neff was born and reared in Ohio, and was a young man when he thence removed to Illinois, where his marriage was solemnized and where he became a substantial exponent of agricultural and live stock industry. In 1873 he came with his family to Iowa and purchased a prairie farm in Des Moines County and eventually developed one of the large and valuable farm

estates of that section of the state. He had given three years of loyal service as a soldier of the Union in the Civil war. He became a member of an Illinois regiment of volunteer infantry and with his command took part in many engagements, including a number of major battles. He participated in the siege of Vicksburg and the Atlanta campaign, and after being with Sherman's forces on the historic march from Atlanta to the sea and thence forward through the Carolinas, it was his privilege to take part in the Grand Review of the victorious forces in Washington, D. C., after the close of the war. He was mustered out in the City of Chicago and was duly accorded his honorable discharge. His health became much impaired as the result of the hardships of his war service, and he never entirely recovered. Mr. Neff ever retained a vital interest in his old comrades in arms and was a regular attendant of the meetings and encampments of the Grand Army of the Republic, he having been affiliated also with the Independent Order of Odd Fellows. His political allegiance was given to the Republican party, and while residing on his Iowa farm he was called to serve in various township offices. He and his wife were honored pioneer citizens of the Hawkeye State at the time of their death. Of their four children the eldest in Lewis J., of this review; Mary J. is the wife of Frederick Fell, who is engaged in the dairy business, and they maintain their home at Walnut, Pottawattamie County; John O. is a successful representative of ranch industry in Wyoming; and George B. is engaged in the real-estate business at Walnut, Iowa. The parents were earnest members of the Methodist Episcopal Church.

Lewis J. Neff received the advantages of the Des Moines public schools and there continued his studies some time in Highland Park College. At the age of nineteen years Mr. Neff initiated his service as a teacher in the rural district schools, and later he served as superintendent of the schools at Manning and at Adair. In the law department of Drake University, Des Moines, he prosecuted studies in fitting himself for his chosen profession, and had the preceptorship of Judge Chester C. Cole, who served with distinction on the bench of the Iowa Supreme Court. Mr. Neff was admitted to the bar in 1899, and has since continued in the active practice of his profession at Walnut, his substantial law business having been extended into the courts of Shelby and Cass counties as well as his home county of Pottawattamie. In addition to his law practice Mr. Neff controls a successful general real-estate and insurance business at Walnut. He has membership in the Pottawattamie County Bar Association and the Iowa State Bar Association.

The political allegiance of Mr. Neff is given to the Republican party, and he represented his county in the Thirty-sixth, Thirty-seventh and Thirty-eighth General Assemblies of the Iowa Legislature—during the period of 1913-15-16-17-18-19. He was assigned to various committees of the House of Representatives and was chair-

man of the committee characteristically loyal, wise and constructive. He gave seven and one-half years of his administration as mayor. His loyalty was further shown as president and secretary of the Iowa State Association. In the World War he was president and treasurer of the local Red Cross campaign. He was influential in the driving of the government war loans and in the raising of money. He and his wife have been members of the Methodist Episcopal Church since 1899.

Mr. Neff has been a member of the Independent Order of Odd Fellows since 1899, is a past grandmaster of the order and a past grand officer of the Sovereign Grand Lodge of the department of Iowa, in which branch he has the rank of lieutenant. He is also secretary of the local Order of Odd Fellows since 1913, and secretary of the Free and Accepted Masons since 1914.

The year 1906 was a notable one for Mr. Neff to Miss Rutledge, daughter of Harlan, Shelby County. His discipline included that of a soldier, having thereafter carried on the duties of a city of Des Moines, a marriage, taught two children, and of her native state. She is the chataleine of her plantation and is a popular factor in the social circles of her home. She is also a member of the active and progressive section of the state.

Mr. Neff is a member of the advisory board of the Iowa Homes for Aged Men and Women, president of the Rebekah Association of Iowa, and is president of the Associated Clubs at Walnut.

JOSEPH W. SELLARD is a prominent medical profession of Iowa. Dr. Joseph W. Sellard is a successful in building a practice and in maintaining high standards and ethics of a physician, he came into a profession, to the advantage of a substantial community, where he has shown sterling citizenship.

Dr. Sellard was born in gold County, Iowa, a son of Dr. David Franklin Sellard. His father, who was a young man when he was preparing for the outbreak of the war, was engaged in his studies, he
