G. Adams is the new president of Community Club. The other officers are J. N. Wilson, vice president; Joe C. Carrier, secretary, and J. F. Traer, treasurer. The nine men elected as members of the executive committee are D. L. Bryan, T. C. Olson, Geo. Lee, Fred J. Martin, Guy E. Parr, R. R. Lent, Chas. Reid and E. K. Allen. At a later meeting the members of the executive committee will be appointed heads of the different standing committees of the club.

The matter of taking care of the balance of some \$2,000 needed to complete the \$10,000 hospital fund, which has been hanging fire for some time, was settled when a motion was made by F. J. Martin and seconded by Sam Sholly, that the Vinton Community Club guarantee the last \$2,000 needed to complete the \$10,000 hospital fund, on the condition that the board of regents begin the work of building at once. ## HON. J. W. HANNA DIED AFTER SHORT ILLNESS

The death of Hon. John W. Hanna, which occurred at the family home in this city Friday afternoon about four-thirty o'clock, following an illness of only twenty-four hours, came as a great shock to the people of Vinton and Benton county, where he had lived his whole life, as well as to the members of the family who find it hard to realize that the husband and father is gone.

Mr. Hanna was taken suddenly ill late Thursday afternoon with severe vomiting spells which continued until the heart had been so weakened that it was necessary to give stimulants to keep it in action. Physicians worked with him continuously, but in spite of everything that could be done he gradually grew worse until death ended his sufferings. The cause of his illness was ptomaine poisoning.

Mr. Hanna had been a life-long resident of Benton county, and was one of the best known men in the county. He was born on a farm in Big Grove township, August 29, 1857, a son of Mr. and Mrs. Alexander H. Hanna. He owned the farm on which he was born, and which was entered from the government by his father. He grew to manhood on the farm and received his education in the public schools, Tilford Academy and Cornell college, which latter institution he attended for one year. After leaving college he devoted his time to farming. For a number of years he was associated with his father in stock-raising and breeding, and of late years has been associated in farming with his son, Leland Hanna.

In December, 1881, Mr. Hanna was married to Rozella Ward, daughter of Mr. and Mrs. Samuel Ward, who were also pioneer residents of Big Grove township. In 1914 Mr. and Mrs. Hanna retired to Vinton, and have since made this city their home.
