POPULAR YOUNG MAN IS CALLED

Lloyd Bosworth Died Saturday
in Lutheran Hospital in
Des Moines

Had Been Operated on Week
Previously—Funeral Serv-
ices Held Monday

A death which came as a shock to the family and the large number of friends was that of Homer Lloyd Bosworth of Des Moines, formerly of Madrid, which occurred about 2:10 o'clock Saturday afternoon in the Iowa Lutheran hospital in Des Moines. He was operated on for appendicitis about a week previously and appeared to be getting along nicely until peritonitis developed. For a day or so previous to his demise it was known that he could not recover.

Lloyd was born in Madrid April 22, 1905, and was 26 years and 17 days of age. He grew to manhood here and four years ago moved to Des Moines where he has since resided. On April 21, 1928, he was united in marriage to Miss Edna Buttler of Des Moines, and to them one child, Ronald Eugene, was born.

In addition to the bereaved widow and baby son, he is survived by his mother, Mrs. W. J. Jenkins of Des Moines; his father, C. D. Bosworth of Florida; one brother, D. LaVerne, of New Haven, Conn. and his two grandmothers, Mrs. C. L. Warden of Madrid and Mrs. C. C. Bosworth of Tingley, Iowa.

Funeral W. S. Criswell in Boone This Afternoon

DIED MONDAY IN BOONE HOSPITAL

Death Caused by Blood Clot on
Brain and Was Entirely Un-
expected by Everyone

Apparently in Splendid Condi-
tion Evening Before, Rally-
ing from Minor Operation

This afternoon from the home east of Luther at 1:30 and from the First Methodist church in Boone at 2:30 are being held the funeral services of W. S. Criswell, former representative in the legislature and prominent citizen of central Iowa, whose death occurred suddenly in the Moore county hospital in Boone Monday morning about 3 o'clock.

Mr. Criswell's death was directly due to a blood clot which had formed on his brain and not as a result of the operation for hernia to which his presence in the hospital was due. The operation was performed Saturday morning and from it he rallied splendidly. His wife and other members of his family who left him Sunday evening had every reason to believe that his evidence of recuperation would soon result in a restoration of normal strength and health.

Just what time the clot formed is unknown. A nurse entering his room sometime after 2 o'clock found him in a semi-conscious condition. She immediately called a physician and summoned members of the family. Before those living in Boone could reach his bedside he had passed away.

The funeral this afternoon is in charge of his pastor, Rev. Harold H. Stark of the Luther Methodist church, assisted by Rev. Grigsby, pastor of the First Methodist church in Boone. The services are being held in Boone in order that a larger number of friends wishing to attend the obsequies may be accommodated.

Was 61 Years of Age

Mr. Criswell was the son of Mr. and Mrs. Levi N. Criswell, pioneer residents of Boone county, and was born in the county on Dec. 23, 1869. His death on May 11, 1931, came at the age of 61 years, 2 months and 18 days. He was the last surviving member of his father's family. He has been a resident of Boone

Later they moved onto a farm in Jackson township where they remained until they purchased the farm in Colfax township, 21 years ago, where the family home has since constantly remained.

To Mr. and Mrs. Criswell were born four children. One of them, Mrs. Bernard Myers, died in 1920. The others are Mrs. Lulu Van Anda of Wakonda, S. D., L. W. Criswell of Boone, and Mrs. Oscar Bark, at home. The sympathy of all goes out today to Mrs. Criswell and the other members of her family, to whom his death came with prostrating unexpectedness. He had not been in rugged health for around a year but continued his activities. Hernia bothered him considerable but it was not until lately that he became reconciled to an operation. The operation is not considered as having a direct bearing on his death, but it is thought the shock may have contributed through a disarrangement of his nervous and physical systems:

Legislator and Farm Leader

Mr. Criswell was elected to the legislature twice and served in one special session which was called during his tenure. He was first elected in 1920 and was reelected in 1922.

A farmer by profession he early became interested in farm organization and co-operative marketing affairs. At the time of his death he was vice-president of the Iowa Farmers Grain Dealers Association and had served on the board of directors of this organization for a number of years. A year ago he resigned as one of the national directors of the Elevator Guide, the official publication of the co-operative grain buyers, a position which he had held for many years.

The last year he became known over the state and middle-west as the leader in the group supporting the federal farm board and the agricultural act. His belief was that while the legislation was not perfect and the board may have made some mistakes, that it was a move in the right direction which was capable of being strengthened, and that if the movement failed in the camp of its friends that the hope of the farm for federal sympathy and assistance would be dimmed for many years. As a result of this position he found himself successfully pitted at the last meeting of the Iowa Farmers Grain Dealers Asso-

HARVEY RISSLER DIES SUDDENLY

Was Born Here and Moved to Perry When 10 Years Old—
Son of Hoyt Rissler

Nephew of Mrs. Perry Lee of This City—Funeral Held in Perry This Afternoon

William Harvey Rissler, 45, son of Mr. and Mrs. H. H. Rissler, died suddenly at 7:30 Tuesday morning at the home of his parents following an illness which lasted over a period of less than three weeks.

Death was due to heart failure brought on by a serious attack of influenza. During the week preceding his death he had been serious but it was thought that he would recover.

Harvey, as he was familiarly known, was born in Madrid and was 10 years of age when his parents moved to Perry. At the age of 17 he secured employment on the Milwaukee railroad as a brakeman. An accident occurred when he was a young man which resulted in the loss of one limb. For many years afterwards he was in business in Perry operating a pool parlor.

He was survived by one sister, Mrs. Ethel Overholser of Des Moines, Ia.
