Copied from a letter to the environmental editor of the Saturday Review is the following observation;

"As a youngster I observed that a wagon with two horses left twice as much manure as did another wagon with only one horse."

The writer referred to the proliferation of aerial pollution caused by bigger automobile engines, with greater horsepower, consuming more gasoline and consequently emitting more and more unburned hydrocarbons into the atmosphere.

He advances the suggestion that vehicles be taxed in proportion to their gasoline consumption.

For example, if a car averaged 30 miles per gallon it would be taxed \$10; while a car averaging 20 mpg would be taxed \$40; and a gas hog averaging 10 mpg would be assessed \$160.

Using this same formula, it would seem that cars averaging 5 mpg or less would pay about \$480 in use tax, making it tough on trailer pullers.

The article I saw did not indicate if the writer was suggesting these taxes in addition to all other autos normally pay.

Cutting horsepower and gas consumption would be one way to cut down big city smog, and may be worth considering.

There would probably be an increase in the use of public transportation, forcing an improvement in this kind of travel and effecting substantial savings to the users in the long run.

Former Congressman L. Thurston Dies Thursday

A long-time Osceola attorney, Lloyd Thurston, died at the Veteran's Hospital in Des Moines Thursday, May 7, following a lengthy illness. He was well known in state circles for his active participation in politics both at state and national level, and as the National Commander of the Spanish-American War veterans.

A native of Osceola, he graduated from the University of Iowa law school and served as

Clarke County Attorney for four years before entering state politics and serving as a state senator for four years.

He was elected to the U. S. Congress in 1925 and served in that capacity until 1939. He was an unsuccessful candidate for U. S. Senator in 1938 on the Republican ticket.

Funeral services were held Sunday, May 10, for Lloyd Thurston, 90, who died Thursday, May 7, at Veterans hospital in Des Moines. The Rev. John McCallum officiated at the 2:30 p.m. service held in the United Methodist Church. Interment was in the Maple Hill Cemetery at Osceola.

Lloyd Thurston was born March 27, 1880, in Osceola, the son of Solomon Thurston and Margaret Malloy Thurston. He received his formal education in the schools of Clarke county and received his Law Degree from the State University of Iowa. On January 13, 1910, he was wed to Louella Bolibaugh in Osceola.

An active attorney, he served in the American Legion, V.F.W., Rotary, Barracks, Legion Auxiliary, served in the Spanish-American War, Philippine Insurrection, World War I, was National Commander of Spanish-American War Veterans, and a member of the State Legislature and Congress from 1926 to 1940. He was also a member of the Iowa State Bar Association; and was affiliated with the Methodist Church.

Surviving relatives include his wife, Louella, of Osceola; two nephews: Jim Wade and wife Marion, of Osceola, and Wayne W. Wade of Detroit, Michigan; a great niece, Mrs. T. Rhoda of Denver, Colorado; a great nephew, Sgt. James A. Wade Jr. of Las Vegas, Nevada; and a sister-in-law, Mrs. Eugene E. Travis of Winter Park, Florida.

He was preceded in death by his parents; a brother, Ralph Thurston; and two sisters, Grace McKeever, and Bernice Wade.

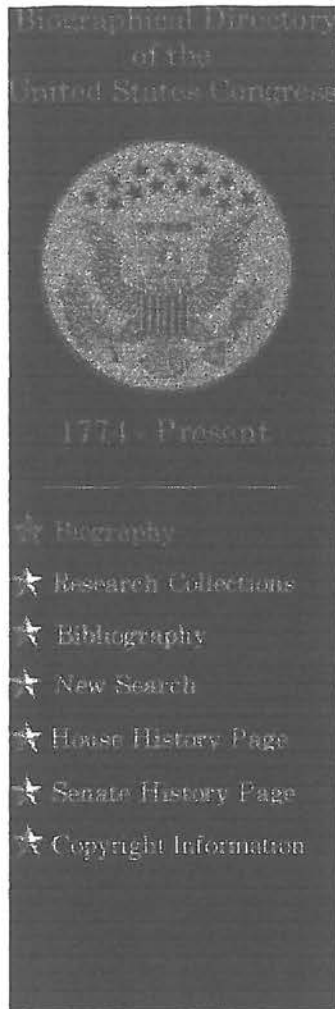

THURSTON, Lloyd, 1880-1970

THURSTON, Lloyd, a Representative from Iowa; born in Osceola, Clarke County, Iowa, March 27, 1880; attended the public schools; during the Spanish-American War enlisted on June 13, 1898, as a private in Company I, Fifty-first Regiment, Iowa Volunteer Infantry, and served with this company during the Philippine Insurrection, and was honorably discharged on November 2, 1899; was graduated from the law department of the University of Iowa at Iowa City in 1902; was admitted to the bar the same year and commenced practice in Osceola, Clarke County, Iowa; captain in the National Guard of Iowa 1902-1906; prosecuting attorney of Clarke County 1906-1910; during the First World War served with the rank of captain in Company C, Twenty-sixth Battalion, United States Guards, at Fort Crook, Nebr.; member of the State senate 1920-1924; elected as a Republican to the Sixty-ninth and to the six succeeding Congresses (March 4, 1925-January 3, 1939); was not a candidate for renomination in 1938, but was an unsuccessful candidate for the Republican nomination for United States Senator; resumed the practice of law in Osceola, Iowa; died in Des Moines, Iowa, May 7, 1970; interment in Maple Hill Cemetery, Osceola, Iowa.

THEODORE W. HILE, proprietor of the Hile Cold Storage Lockers at Russell, entered upon his current business venture with considerable experience in grocery retailing and farm management, occupations well designed to benefit him in the directing of his present enterprise. He recently sold his store in Russell to make the Cold Storage Lockers his central business interest. In a vast agricultural area such as Iowa, the future of such an undertaking is secure, and Mr. Hile's decision shows excellent business foresight. He is a citizen who takes a vital interest in the affairs of his community, and he has recently been re-elected for a three-year term as president of the school board.

Theodore W. Hile was born at Spring Ranch, Nebraska, December 13, 1906, son of Joseph E. and Pearl A. (Wheeler) Hile. His father, who is a native of Easton, Pennsylvania, has been a farmer most of his life. Indeed, he operated a farm in Nebraska for about sixty years. He now lives in retirement at Russell. His wife, the former Pearl Wheeler, was born in Waukeshaw, Wisconsin.

Mr. Hile was brought up in his native state, received his early education in the local grade schools, and graduated from the high school in Franklin, Nebraska, in 1926. He then entered Nebraska State University at Lincoln and on graduation received the degree of Bachelor of Science in the department of science and agriculture, in 1931. His first business connection was with Swift and Company at Omaha, where he remained for two years, and he then associated himself with the stores of the Great Atlantic and Pacific Tea Company, also in Omaha, for a like period. Mr. Hile then engaged in farm operation, an occupation not unfamiliar to him, and for seven years successfully ran a farm near Seward, Nebraska. When he first came to Iowa, he engaged in farming there, situating in Lucas County for four years, before returning to the grocery business. This was in 1944, and the retail grocery which he opened at that time, was sold in 1949, having been superseded, in his interest, by the cold storage plant which he began to develop at about the same time. Mr. Hile is of the progressive type who can accurately gauge the significance of such developments.

He is also active in promoting the welfare of the community as a member of the Chamber of Commerce and president of the Russell school board. He is a member of the Russell Sportsman's Club, and a proponent of the views of the Republican party. Mr. Hile is a Methodist in his religious faith, and is a member of its official board. Hunting and fishing constitute his favorite outdoor diversions.

Theodore W. Hile married, on September 3, 1932, Dorothy L. Marquardt of Avoca, Nebraska. She is a daughter of Louis and Caroline (Beckord) Marquardt, both of whom were Nebraskans by birth. Louis Marquardt was the operator of a grain elevator at Avoca for many years, and died in 1934. Caroline (Beckord) Marquardt still resides in Avoca. Mrs. Hile takes great interest in church work, and

is a Girl Scout leader. Mr. and Mrs. Hile are the parents of three children: 1. Christine, born January 22, 1935. 2. Nancy, born August 26, 1939. 3. Roger, born June 7, 1943.

HON. LLOYD THURSTON, of Osceola, has represented at various times during his public career, two districts of the state of Iowa in the Congress of the United States, and he has served his constituents in the Iowa Senate. An attorney by profession, Representative Thurston became well-known on the national scene during the 1930s, as a member of the important congressional Rules, Appropriations, and Ways and Means committees; and he is widely recognized as author, radio speaker, and as outspoken proponent of solvency in government. He is a veteran, who engaged in constructive activities in veterans' affairs, and he authored the bill creating the Department of Agriculture in Iowa.

Born March 27, 1886, in Clarke County, Lloyd Thurston is a son of Margaret Thurston. His parents settled in Iowa in 1871. Receiving his preliminary education in the public schools of Osceola, Mr. Thurston thereafter entered the State University of Iowa, from which he was graduated in the class of 1902, having received his training in the law. He was admitted to the bar the same year, and began practice in Osceola.

Mr. Thurston early made his acquaintance with public office. He was elected county attorney for Clarke County in 1906, serving until 1910. In 1921, he was elected, without opposition, to represent his district in the Iowa State Senate. He retained his seat in the state legislative body until 1925, when he was selected as candidate to represent the Eighth Iowa District in the Congress of the United States. Elected to office, he served the people of this district until 1933, when he was elected to represent the Fifth Iowa District in Congress. This district comprises the counties of Appanoose, Clarke, Davis, Decatur, Jasper, Keokuk, Lucas, Mahaska, Monroe, Poweshiek, Ringgold, Union, Wapello, and Wayne.

In the national Congress, Hon. Lloyd Thurston was successively a member of the Rules, Appropriations, and Ways and Means committees, and while on the last-named was also a member of the committees on Insular Affairs and Coinage. In 1935 he was a member of a Congressional Committee to inaugurate a Philippine Commonwealth at Manila, and he was one of six members appointed by the Congress to represent the United States Government in commemorating the fiftieth anniversary of the sinking of the battleship "Maine," the ceremony being held at Havana, Cuba, February 15, 1948. Mr. Thurston's selection for this honor was a most logical one. While not a representative in Congress at that time, he had served in the Spanish-American War and the Philippine Campaign, for which military service he had volunteered. He had previously been an officer in the Iowa State Guard. In 1948, he was general chairman of the Golden (Fiftieth) Encampment of the Spanish-American War Veterans, convening in Washington, D. C., in August of that year. Lloyd Thurston also was commissioned for service in World War I. He is a member of the following military organizations: United Spanish War Veterans; Philippine Veterans Association; Veterans of Foreign Wars; American Legion; Uncle Sam's One Two Three Boys (who have served their country in three conflicts); and the Caribon Society. He has served as inspector general, chief of staff and of

Iowa Department commander of the United Spanish War Veterans. In his legislative capacities, Hon. Lloyd Thurston has been the author of several statutes benefiting veterans.

While Iowa State Senator, Mr. Thurston was co-author and sponsor of a bill creating the Department of Agriculture of his state, a work of great and permanent value in a commonwealth which leads in agricultural production. Although he last represented the Iowa Fifth District in the Congress of the United States in 1939, he has remained in the public eye through his many welfare-centered activities. He has spoken many times on the radio on cultural subjects, international affairs, and matters of importance to veterans and those interested in sound government. For many years he was a trustee of the American Child Home Finding Association, and belonged to the Jefferson National Expansion Commission. He retains membership in the Pioneer Lawmakers of Iowa, and is a charter member of the Clarke County Farm Bureau and his American Legion post. Mr. Thurston serves on his library board, as its president, and he is past president of the local unit of the Rotary International.

Since resuming private life and private legal practice in 1939, Hon. Lloyd Thurston has maintained an office in Osceola. He is entitled to practice before the Iowa Supreme Court, the federal courts, and the United States Supreme Court. Mr. Thurston is a Republican in his politics.

In 1910, Lloyd Thurston married Louella Bolibaugh, daughter of Dr. W. R. and Lavada Bolibaugh. Mrs. Thurston was born in Clarke County, and received her education in the public schools of Osceola and at Iowa State Teachers College. She is a member of the National Federation of Women's Clubs, and serves on several of its state committees. She is also a member of the Daughters of the American Revolution, the P. E. O. Society, the Women's Congressional Club of Washington, D. C., and of the auxiliaries of the Spanish-American War Veterans and the American Legion. She is a life member and curator of the State Historical Society of Iowa, and, being vitally interested in political affairs and good government, is a member of the Fourth District State Central Republican Committee, which she serves as co-chairman. Another of Mrs. Thurston's interests is travel, and she gives travelogues in costume, particularly on China, Japan, the Philippines, Europe, and Mexico. Another of her hobbies is collecting antiques.

Mr. and Mrs. Thurston attend the Methodist Episcopal Church. They have no children; and they make their home in Osceola.

ARNOLD O. WIRSIG, M.D.—The Wirsig family has lived in Iowa since 1856, and in the intervening period has established itself among those making the greatest contribution to progress and welfare. Dr. Arnold O. Wirsig, of Shenandoah, is a member of the third generation of the family in this state, and he has been making his own contribution as a physician and surgeon. Having for years specialized in surgery, he is noted among railroad men and the general citizenry for this specialty. Outside the profession Dr. Wirsig is interested in farming and in his organizational memberships, which are numerous and varied.

Dr. Arnold O. Wirsig was born in Lee County on March 9, 1884, the son of Paul and Ellen (Vornkahl) Wirsig. His father, a farmer and a native of Dres-

den, Germany, was one of the eight sons of John Gotlieb Wirsig, who left Germany in 1856 in order that his sons might avoid service in the German Army. The family had hardly established itself in Iowa when the Civil War broke out, and to balance things one of the sons, Adolph, ran away from home and joined the Union Army. John Gotlieb Wirsig bought land in Lee County and spent the remainder of his life as a farmer. His son Paul, father of the doctor, having chosen farming as his career, also purchased land in Lee County and resided on the same farm until his death in 1932, at the age of seventy-seven. His widow, Ellen (Vornkahl) Wirsig, died on December 24, 1949, in which year she had celebrated her ninety-first birthday. Both Mr. and Mrs. Paul Wirsig were active for years in the German Evangelical Church in Lee County. Mr. Wirsig was a leader in the Republican party organization and he held several township offices. Besides the doctor, there were four children: Ellenora, the wife of Frederick Fett, a Lee County farmer; Arthur E. Wirsig, a dentist at Farmington; Marvin A., a farmer in Lee County; and Cordelia, who resides on the old homestead in Lee County, where she lived with her mother during recent years.

Dr. Arnold O. Wirsig, the third born among the five children, first attended the rural schools in Lee County, after which he was a student at the Farmington High School. Upon his graduation from the high school, he entered Drake University, in Des Moines, where, in 1912, he received the degree of Doctor of Medicine. Inasmuch as the Drake University Medical School became, in 1913, a part of the State University of Iowa College of Medicine, Dr. Wirsig is now a recognized alumnus of the university. For eighteen months he interned at Iowa Methodist Hospital. In the World War I period, Dr. Wirsig volunteered for service with the United States Army Medical Corps and was commissioned a first lieutenant. He assisted Dr. Arthur Steindler in reconstruction work among the wounded veterans, and, in 1919, obtained his honorable discharge.

On May 23, 1919, Dr. Wirsig established himself in practice in Shenandoah, where he has remained ever since, with offices at 227 Keshlear-Rankin Building. His reputation as a surgeon has spread into the adjoining states of Nebraska and Missouri, and he is on the surgical staff of the Memorial Hospital in Shenandoah. In 1943 he was appointed a member of the State Board of Health by Governor George A. Wilson, serving in that capacity for two years, and he received numerous citations from the President of the United States and the Governor of Iowa for his work as examining physician on the Board of Examiners in Page County during World War II.

Dr. Wirsig is a member of the Page County Medical Society, the Iowa State and American medical associations, and the American Association of Railway Surgeons. Fraternally, he is affiliated with the Ancient Free and Accepted Masons, holding the Thirty-second degree in the Ancient and Accepted Scottish Rite and belonging to Za-Ga-Zig Temple of the Ancient Arabic Order of Nobles of the Mystic Shrine at Des Moines, and with Shenandoah Lodge of the Benevolent and Protective Order of Elks; and he is a member of Phi Delta Gamma, national medical fraternity, Chi Delta, social fraternity, the American Legion, and the Omaha Athletic Club. He is surgeon for the Wabash Railway Company and an honorary citizen of Boys' Town. He is a Republican, and farming and cattle breeding are his hobbies.

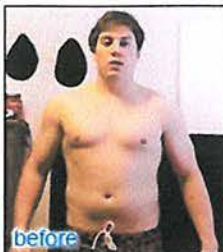
