QUINN IS HELD; WIFE FAITHFUL

Kansas City, May 18. (AP)—Ex-pressing faith in her husband's as-assertion he did not kill Zexia Grif-fith, 34, and Jessie Griffith, 24, Oklahoma school teachers, Mrs. Earl Quinn, was to appear at an extradition hearing in Jefferson City today.

A warrant charging Quinn, 30-year-old ex-convict, with the murder of the sisters arrived here by special delivery yesterday.

Mrs. Quinn said she would appeal to Governor Henry S. Caulfield for assurance of protection in the event her husband was returned to Ton-kawa, Okla., near the scene of the slaying last Dec. 28. She said she had no fear of the outcome if he was "given justice."

Quinn, arrested in Omaha early Friday, when he attempted to meet his wife, came here voluntarily with Kansas City detectives, Mrs. Quinn said.

A year ago Mr. Tuck found that his health was breaking, and he and his wife left the farm where they had lived since their marriage, and came to Corning to make their home. It was soon found that his trouble was cancer and from that time he failed rapidly, but still clung to life, always with a cheerful hopefulness until his passing Sunday. Funeral services were held Tuesday at 2 p. m. from the Federated church, with Rev. N. E. Lambly in charge. After the church services the Masonic lodge, of which he has been a prominent member for years, took charge and conducted a beautiful service at Prairie Rose cemetery, where the body was laid to rest.

John Colborne Tuck, son of John and Mary Tuck, was born in York, Haldimand county, Ontario, May 20, 1867, and died May 17, 1931, at the age of 64 years, 11 months and 26 days. He was married to Miss May Anderson October 1, 1894, who went with him as a bride to the farm south of town, where they lived until his health failed. During the past year they have lived in Corning, where Mrs. Tuck and Miss Nellie Tuck, Mr. Tuck's sister, have tenderly cared for the suffering loved one.

Mr. Tuck was a staunch Republican, having cast his first vote for President McKinley. During his early years he held numerous minor offices in the county and always kept in close touch with politics. During the war his activities in various lines of patriotic endeavor were outstanding. During the 39th and 40th General Assemblies Mr. Tuck represented Adams county as senator. As such he always stood for the right and was unmoved by any influence except that which appealed to his sense of justice and right. He was a member of the Episcopal church in Ontario and after coming here, he and his wife united with the Christian church at Fairview and served faithfully there until they came to town. After coming to Corning he worshipped with the Federated church as long as his health permitted.

Mr. Tuck is survived by his widow, his sister, Miss Nellie Tuck, and two brothers, W. A. of Bradford, Ontario, and R. A. of Ashawa, Ontario. Miss Tuck has been here for the past year but the brothers were unable to come for the funeral, the distance being so

SENATOR TUCK AFTER LINGERING ILLNESS, DIED

PASSED AWAY AT HIS HOME
IN CORNING EARLY
SUNDAY MORN.

HAD MANY FRIENDS

Prominent Taylor County Farmer
and Former Senator For
Adams-Taylor Counties

J. C. Tuck, until a year ago, a prominent Holt township farmer in Taylor county, passed away at his home in Corning, following a malady he has suffered for the past few years. Mr. Tuck has farmed practically all his life, and had spent the greater part of it here in Taylor county.

Senator Tuck

Senator Tuck was a member of the thirty-ninth and fortieth General Assemblies, representing Adams and Taylor counties, and was once a candidate for Auditor of State. He cast his first republican ballot for McKinley in 1896. Introduced in the Iowa Assembly a bill which provided a county budget system, which was enacted into law.

The passing of John C. Tuck shortly after midnight Saturday brought sorrow to a community of admiring and loving friends and release to a suffering body which had borne well and valiently its share of the burdens of life. TURNER SAYS THE 'LOBBYISTS' KILLED BILL

THEY HAD HELP OF LIEU
ENANT GOVERNOR, EX-
ECUTIVE CHARGES.

CARVES WAY THR

Citizens Of Iowa Know How E
Business Works Against
Governor Turner

Governor Turner Tuesday charged defeat of the state income tax in the 1931 legislature of the senate and "lobbyist through the help of the lieutenant governor".

He said he vetoed the state road bond enabling act because the senate, "in high handed procedure", attempted to attach a simple enabling bill a provision that "would have added 1.8 miles of paving to the 5,000 mile program."

The legislature which just closed, he said in a radio address, was attended by the "greatest lobby of special privilege in the history of the state."

He made the speech, he explained, to put the people in possession of the true facts.

"It is necessary to do this," said, "because of the colored misleading statements that have appeared in some of the newspapers published in the state."

Saying he was making plain "who was responsible for failure to carry out the mandate of the people," the governor asserted the house "stood by its constituents in the fight against special privilege," and a "courageous minority of senators fought the people's fight to the very last."

He mentioned the lieutenant governor, Arch W. McFarland several times, but never by name and observed that "perhaps the greatest question before the electorate is the one of selecting lieutenant governor and men the legislature who will carry out their campaign pledges."

He designated the job against the income tax as "maintained by the public utility special interests and selfish individuals who wished to escape their share of taxes."

On the road bond veto, he said he "stood ready and the majority of the house stood ready to forward in good faith with the program as it had been outlined to the people in the last two years."

"When in the closing hours of the session, without a printed bill, the attempt was made to add a provision making mandatory the paving of several hundred additional miles, thus adding \$50,000,000 of indebtedness for road purposes, I thought was unfair to the people of Iowa," the governor said.

He expressed his belief that the 5,000 miles of paving and 1,800 miles of gravel contained in the constitutional amendment invalidated by the Supreme court will be accomplished.

"The time has come," he said "when we should plan a program for secondary roads that will reach farming communities the state so as to give the people of the paved road system by providing for some kind of surfa
