SUDDEN DEATH OF J. H. AIKEN SHOCKS

Served Six Terms in Legis-
lature and 15 Years on
School Board

Few tragedies in recent years
have so stirred Ida county as the
untimely death Tuesday morning,
January 14 of John H. Aiken, six
times representative from Ida
county in the General Assembly
and a member of a genuine Ida
county pioneer family.

Mr. Aiken's body was found
hanging in the second story of the
Pilcher garage and implement
building, about 7:30 a. m. The dis-
covery was made by Ralph Pilcher,
an employe, whose work took him
early to that part of the building.

John H. Aiken, one of the five
sons of Benjamin Franklin and
Patience Williams Aiken, was born
at Iowa City, Iowa, March 27, 1875
and was in his sixty-first year. The
parents came of a long line of
American descent originating in
Vermont. The family came to the
valley of Soldier river in 1876 and
were pioneers in that portion of
Ida county. One of the early be-
lievements sustained by the fam-
ily was the loss of a fifteen year
old brother of John's in October
1879. A prairie fire swept over
the Soldier valley and in the effort
to save some stock, the lad was
cut off by the flames and perished.

John Aiken grew to manhood on
the extensive Aiken farm proper-
ties in Grant township and re-
mained on the place after his par-
ents moved to town. The father
died in 1900 and the mother three
years later.

He was married to Henrietta
Hass of Holstein, October 21, 1900.
and a short time afterwards, they
moved to Valley Junction where
he worked as a commission man
for about nine months. Next they
resided in Battle Creek for 18
months and then came to the home
that had been his father's and to
direct extensive cattle feeding
operations.

Three daughters were born to
Mr. and Mrs. Aiken, Patience at
home, Mrs. Thelma Raveret, Niles
Center, Ill., and Mrs. Virginia
Nonemann of Clinton, Ill. There
are three little grandchildren.
These, together with his wife, sur-
vive him.

Mr. Aiken was a republican in
politics. He served for fifteen years
as a member of the Ida Grove
board of school directors and served to
bear his fine intelligence and good
judgment in the solution of school
problems. He was a member of

 board of education and brought to
 bear his fine intelligence and good
 judgment in the solution of school
 problems. He was a member of
 the board during the superintend-
 ency of Ray Latham, now president
 of Iowa State Teachers college. Mr.
 Latham said that Mr. Aiken was
 one of the best posted and effi-
 cient board members, he had ever
 served under.

In 1920 he was elected as Ida
 county's representative to the Iowa
 General Assembly and was re-
 elected five times, quitting office
 January 1, 1932. During that
 period, he attended six regular and
 two extraordinary sessions of the
 legislature. He was conservative
 in his views and a brake against
 the enactment of hasty, ill-advised
 and half baked legislation. He op-
 posed with all his might the cen-
 tralization of political power in Des
 Moines and Washington, feeling
 that it rightfully belonged within
 the jurisdiction of the common
 people who gave it.

He was appointed assessor of Ida
 Grove city more than a year ago
 and discharged these duties in 1930
 and had been sworn in for similar
 service only last week. In this work
 he was thorough and conscientious.

Mr. Aiken was a man of intel-
 ligence and understanding. He was
 a very interesting conversational-
 ist and a great reader. He was
 prepared to defend his convictions
 with courage. He was tender and
 loving to his family, and consid-
 ered it a privilege to serve them un-
 selfishly.

Mr. Aiken was a member of the
 Masonic order, of the Eastern Star
 and a charter member of Sioux
 City Consistory of 32nd degree
 Masons.

His funeral will be held this
 Thursday afternoon, with brief
 services at the home at one thirty
 and public services in the Metho-
 dist church in charge of Rev. G. W.
 Dunn at two o'clock. The Masonic
 order will have charge of the
 burial.


