Mr. Grimwood, a retired pharmacist, died this morning (Monday) at 4:10 at Mercy hospital.

He is survived by a sister-in-law, Mrs. Mantie Grimwood, with whom he made his home, and nieces and nephews.

He was born Dec. 8, 1863, in Allamakee county, the son of Isaac and Eliza Grimwood. He had been a resident of Oelwein 29 years and resided at 26 3rd Ave. S.E.

Prepared to take up Tuesday morning the first of the big appropriations bills. The measure would provide funds for the State Board of Social Welfare to administer such programs as old age assistance, aid to dependent children, and aid to the blind.

Also deferred temporarily a bill to divorce county agricultural extension offices from farm bureau federation units.

Received a new bill calling for appointment of a nine member capital improvement commission to consider either treatment of the statehouse to preserve it or building a new outside wall.

Sent to the Senate one of two bills designed to "put teeth into" truck enforcement laws. The second measure appeared practically ready for passage. Gov. Leo Hoegh had asked the Sifting Committee for prompt action on both measures.

SENATE

Recalled from the House for correction a bill assuring widows of policemen and firemen \$10 per month in death benefits for each child under 18. The Senate then passed the corrected measure and sent it to the governor.

Amended and passed a measure giving all state employees three weeks vacation after 10 years. The measure now goes back to the House which had provided for 3 weeks vacation after five years.
