E. A. ELLIOTT IS DEAD AT 92

The Rev. Elmore (E. A.) Elliott, 92, retired minister and a former Des Moines city councilman and Polk county representative, died Thursday night at Iowa Lutheran Hospital.

The Rev. Mr. Elliott suffered a stroke Thursday morning at his home at 2603 E. Fourteenth st., where he had lived the last 51 years.

Born in Indiana

Born on a farm in Indiana across the Ohio river from Louisville, Ky., he attended Westfield College, Westfield, Ill., and former Western College at Toledo, Ia.

He came to Des Moines in 1898 when he married his wife, Lola, whom he met at Western College.


The Rev. Mr. Elliott was an ordained minister of the Evangelical United Brethren denomination.

He served the former Castle and Miller Memorial Churches in Des Moines and other United Brethren congregations at Dawson, Van Meter and Elkhart, and Congregational Churches at Ankeny, Johnston, Bondurant and Granger.

During most of these ministries he continued to make his home in Des Moines.

The tract is located west of Forty-seventh street, approximately between Euclid and Ovid avenues.

According to the park board, the pool would be built at the north end of the property, and the southern part would be devoted to parking. Space would be provided for about 300 cars.

Park Board President Harold Teachout said the pool would be about the size of the present Birdland Pool.

The commission held up action on a park board request for approval of plans for buying a 6 1/2-acre pool site just south of Watrous avenue, between S. W. Fourteenth and S. W. Thirteenth streets. Members ordered a staff investigation of the tract.

Retired 10 Years

Although he retired from the ministry 10 years ago, he often officiated at weddings, the last on Sept. 28 at Granger.

The Rev. Mr. Elliott was as well-known here for his political as his ministerial activities.

A Republican, he served five terms in the Iowa house of representatives, from 1924 to 1930 and was re-elected in 1932 and 1934.

Earlier he served two terms on the city council, starting in 1918 and 1920, as city finance commissioner. In 1936 he waged a hard but unsuccessful campaign for mayor against Joe H. Allen.

He tried in 1932 for the nomination for Polk county sheriff but was defeated in the primary.

For a time he was a claims adjuster for the city legal department.

Surviving besides his wife is a sister, Mrs. Thomas Vardenius, Portland, Ore.



The Rev. Mr. Elliott, 92, died Thursday night at Iowa Lutheran Hospital. He suffered a stroke Thursday morning in his home at 2603 E. Fourteenth st., where he had lived the last 51 years.

In addition to his ministerial work from which he retired 10 years ago, the Rev. Mr. Elliott was a former Des Moines city councilman and a former Polk County state representative.

Contests Result Of Auditor Race

FORT MADISON, IA. (AP)—County Auditor W. L. Hawbaker Friday said he was contesting the result of the Lee County auditor's race in the Nov. 6 general election.

Hawbaker lost his bid for re-election to E. F. McDonough by 251 votes, the official canvass showed.

Hawbaker specifically asked a recheck of votes from the fourth ward of Fort Madison and the seventh ward of Keokuk. He said 300 ballots were overlooked in the seventh ward in Keokuk. The contest court will convene here the last week in December.

2 Campaign Reports Late

Two Democratic candidates for congress were among several who filed their campaign reports with the secretary of state Friday, one day late.

The deadline for reporting was Thursday, 30 days after the Nov. 6 election. There always are some late filers, however, and no action is taken against them, the secretary said.

The Democrats are the Rev. Merwin Coad of Boone, the first Democrat elected to the house of representatives from Iowa since 1940, and Mayor Michael Micich of Charles City, who ran unsuccessfully in the third district.

2 File in Time

The secretary of state's office said that just before the deadline Thursday it received reports from Representative Fred Schwengel, Davenport Republican re-elected in the first district, and State Treasurer M. L. Abrahamson.

Coad, who defeated Republican Representative James I. Dolliver of Fort Dodge in the sixth district, reported receipts of \$5,608 and expenditures of \$5,908.
