DRASTIC LOCAL OPTION LIQUOR BILL OFFERED

Anti-Saloon League of Iowa Sponsors Act To 'Cure Evils'

Moines—(AP)—Iowa senate house "drys" placed before the chambers Monday a drastic option liquor bill which, one of the sponsors said, would "wipe out many of the bootleg and other evils in the present system." The sponsors said the bill was drafted by the anti-saloon league of Iowa. Sen. Ora E. Husted (R) of Truro and Sen. George Hopkins (R) of Erie Center introduced the bill in the senate and a group of dries led by Rep. Harry E. Morrow of Hopkinton, a minister, filed a companion measure in the house. The bill would permit cities and towns, through local option elections, to outlaw operation of liquor or beer establishments in their areas. Although state liquor stores are not mentioned specifically in the measure, terms of the bill would allow dry towns and cities to oust them.

A sore spot between federal and local law enforcement officers—sale by the internal revenue department of retail liquor dealers' tax stamps—would be erased under terms of the measure, which sets up a dividing line between wet and no license territory.

Also Includes Beer

It would make "possession of a United States special tax stamp" in cities and towns which had voted to oust liquor "prima facie evidence of guilt under this act."

The bill would include beer under the drastic local option regulations by defining liquor as any beverage containing more than one-half per cent of alcohol by volume.

Husted, long a spokesman for dry forces, said he believes "this bill would clean up a lot of the rottenness in the liquor situation." Dry law with similar provisions since 1890 and Hoyer first became local

UAW LAUNCHED SUDDEN DRIVE ON CHRYSLER

Asks Recognition As Mysterious Tear Gas Attack on Sunday

Detroit—(U.P.)—Recognition of United Automobile Workers as a bargaining agency was demanded by the Chrysler Corporation Monday after a mysterious tear gas demonstration disrupted a union meeting called to celebrate the latest step toward unionization completely the automobile industry.

Richard T. Frankenstein, UAW organizer, announced in a telegram containing the demand would be sent directly to Walter Chrysler, head of the corporation "and he can turn it over to what he wants to."

Police began an intensive investigation of the tear gas episode, which came as workers and their families were marching into the fairgrounds coliseum after a "victory" parade which started in front of the Motor Company's big Highland plant.

Worker Beaten

Light bulbs containing a poisonous gas which, according to investigators, generated tear gas when exposed to heat, apparently were thrown through ventilators. In the ensuing confusion, George Vargo, a worker in the Dodge division of Chrysler, was seized and beaten by workers who believed him guilty of the attack.

Riot calls brought 25 police to the auditorium. Vargo was handcuffed and taken to a hospital where he was treated for cuts and bruises. He was released later.

The union's demands on Chrysler were prepared only 10 days before settlement of a 44-day strike which affected 135,000 employes of the General Motors Corporation, and negotiations still were progressing between union leaders and General Motors executives for wage and hours agreements not including the strike peace.

Mr. Lange had a host of friends in

 state. He served as state senator
 from Dubuque County from 1926 to
 1930, the only Republican ever elect-



