Local Ambulance From All Angles

Crosslines" Decatur Co. owns two cars they keep based at the hospital. Five men work at the hospital when not on the ambulance. An Aide is sent with them on call. Lucas Co. also has an ambulance at the hospital, but their men are on call only. When Mr. Hutchinson took a person to the Lucas Co. Hospital, he asked why they had not picked up the patient and was informed that they had no one on duty. One thing about the hospital based ambulances is that they do not like to take their patient to another hospital. All three of these services were paid from the hospital millage. They are allowed 1 mill for general and 1 mill for special. When asked how hospitals could get money for the service if counties could not, the reply was either to budget for it or raise prices.

The Board of Supervisors reported they had levied to the limit and so could not levy any millage for an ambulance. However, if the state legislature would give them authority to levy for an ambulance, 1 mill would



Stroke Is Fatal Tuesday To Judge Harry F. Garrett

Judge Harry Garrett, of Corydon, born December 24, 1887, died at the Wayne county hospital at noon Tuesday, August 10, 1971. His death followed a second stroke. The first stroke had occurred early Sunday morning. It seemed that he was responding well to treatment when the second stroke came. The Judge was born and spent his entire life in Corydon, with but brief exceptions. He was a son of the late Mr. and Mrs. John E. Garrett.

graduating from high school in 1907. He then went on to the State University of Iowa law school during the next four years and returned to Corydon to enter the practice of law.

He united in marriage with Louise O'Neal of Osceola in 1927. Both Mr. and Mrs. Garrett made a great host of warm friends in the community and elsewhere.

Attorney Garrett was elected repeatedly to the office of county attorney in Wayne county. He served in the army during World War I. Returning he served as assistant attorney general of Iowa for a period of four years. He was nominated attorney general by his party but failed to be elected.

Later he was nominated and elected to the Supreme Court of Iowa and served with distinction in that office for a period of two years.

He then returned to Corydon to continue his law practice here. Two years ago he had built a new home in Corydon. His last illness came swiftly and unexpectedly. It is a blow to a host of relatives and friends.

A four-man movie crew will film highlights of Old Settlers' Day Celebration August 14.

J. C. Experimental Productions will produce color, with stereo sound. JCXP's producer is Booth.

Booth, who will be a Simpson College sophomore involved in film-making for five years. He has done hour length documentaries, and done preliminary work. He has also done sports filming, television video graphed a 1970 political campaign.

Film-making is a popular medium of self-expression for young people now, Booth says, but most of it is done quickly and "for shock value—the contents of drugs or anything."

Booth believes he can make a worthwhile audio by just "letting things happen and simply being an observer."

HARRY F. GARRETT

Served on the Iowa Supreme Court from December 15, 1958, following his election until December 31, 1960, when he was succeeded by Justice Bruce M. Snell.

Born at Corydon, Iowa, December 24, 1887. He was graduated from the University of Iowa College of Law and thereafter was admitted to the Iowa bar in 1911. In that year he commenced the practice of law at Corydon which he engaged in continuously until his election to the court except for the time he served in World War I as a Regimental Sergeant Major and later as an Assistant Attorney General from 1933 to 1937. He was a member of the 44th General Assembly (1931-1932). He also served as County Attorney of Wayne County for three terms.

After leaving the court Justice Garrett returned to the private practice of law at Corydon. He died at Corydon August 10, 1971.
