E. P. Laughlin, 80, Imogene, prominent Fremont county stockman, died Tuesday Jan. 9 at Mercy hospital, Council Bluffs. He raised registered polled shorthorn cattle. He served four terms as state representative from Fremont county, in 1926, 1930, 1932 and 1934. He attended Christian Brothers College at St. Joseph, Mo.

Survivors include two sons, Matthew J. Emerson, and Lewis E. Imogene; one daughter, Mrs. Robert (Lucille) Jardon, Randolph; two sisters, one brother and 19 grandchildren.

Services will be held Friday at 9 a.m. at St. Patrick's in Imogene with the Rev. F. W. Doyle officiating. Burial will be at Mt. Calvary cemetery. Buntz Tawser Funeral Home, Shenandoah, is in charge of arrangements.

IMOGENE — Funeral Mass for former state representative E. P. Laughlin, 80, is tentatively scheduled for 9 a.m. Friday at St. Patrick's Catholic Church here.

Mr. Laughlin, a prominent Fremont County farmer and Polled Shorthorn cattle breeder, died Tuesday at a Council Bluffs hospital where he had been a patient since Dec. 12.

He was a graduate of Christian Brothers College, St. Joseph, Mo., and taught public school in Fremont County for several years.

He was first elected to the Iowa Legislature in 1926 and served one term. He was re-elected in 1930 and served continuously until 1936. He was a Democrat.

Survivors include two sons, Lewis of Imogene and Matthew of Emerson; daughter, Mrs. Robert Jardon, Randolph; 19 grandchildren; brother, John of Amarillo, Tex.; two sisters, Mrs. J.J. Saier, Shenandoah and Mrs. T. L. Clark, Kent, Minn.
