Some details of the doctor's illness and a tribute to him is contained in the following written by Mrs. Scholte: "We are sorry to hear of the death of Dr. Carl Aschenbrenner who practiced medicine here for many years. The Doctor had been in poor health all winter. Everything was done to restore him to health that was possible. He had the very best of medical care but continued to fail. to the utilization of the Des Moines River, of the railroads and the highways.

Governor Kirkwood was succeeded in his office by a Marion County citizen. Colonel William M. Stone came home from the battlefield, enclawed with an aura of magnificent courage, and was almost at once nominated and elected to succeed Kirkwood. He had been a spectacular leader of political fields as well as in war. He was in Washington, D. C., on a public errand, and was present in Ford's Theatre the night of the assassination.

He served four years as a conspicuous and honorable servant of the people of Iowa as its first magistrate and retired worse off in a pecuniary way than when he was inaugurated. No question has ever been raised as to his official integrity.

The Spanish American and World Wars afforded the sons and grandsons of the veterans of the Civil War opportunity to display valorous alacrity in coming to the support of the Stars and Stripes and sustaining it in Cuba, the Philippines, on Flanders Field and upon the waters of the Seven Seas.

Marion County, being along the stream of access from eastern Iowa to the forks of the Des Moines, led, of course, Captains of the Cross, first in their brogans, sometimes in moccasins, and finally to the best clothed men of pulpit, and of all Christian faiths.

At the bar, on the bench and in legislative halls, Marion County has never taken a back seat in conference or controversy. She

If you should notice that the correction and completion of the Iowa State capital grounds, in 1913, the writer hereof avers he got the idea in 1912 in Marion County at the fireside of Benton Ruckman carried it to Governor B. F. Carroll, then to Governor George W. Clarke, both of whom approved and officially advocated it. Nothing has better awakened state pride and Iowa self appreciation, for it achieved the most notable retrieval of landscape error in any capital in the United States of America.
