Services were held at the Cope- land home in Waukee, Thursday, April 5, for Harry F. Copeland, 78, a widely known, long-time, resident of the Waukee commu- nity. He passed away at Mercy Hospital in Des Moines, on April 3.

Born in Illinois, he moved into Dallas County, with his parents, in 1894 and spent the remainder of his life near Waukee. He was a farmer and made detailed studies of marketing and feeding trends. He served as a member of the State Legislature for two terms, as a member of the County Board of Supervisors for a number of years and was a director of the Farm Mutual Telephone Company for 50-years.

John Hanlon officiated at the memorial services and interment was at the Waukee Cemetery. Casket bearers were Mike Fitz- gerald, John Hanlon, Elmer Kaser, Leo Garland, Ralph Hunter and Jack Geneser.
