Dewey Emmitt Goode

Dewey Emmitt Goode, son of Louis Emmitt and Rosie Gravitt Goode, was born June 2, 1898, in Bloomfield, Iowa, and died Sunday, March 23, 1972, in the Davis County Hospital at the age of 73 years, 9 months, and 24 days.

He received his education in the Bloomfield schools and had always resided within a mile of his birthplace.

As a young man he was baptized in the Church of the Nazarene.

He was married to Ione McIntyre June 10, 1917. For two years following his marriage, he farmed near the west edge of Bloomfield, after which he worked for his father in the produce business in Bloomfield. Following his father's death in 1933, he joined with his twin brothers, Dean and Doran, and continued this partnership until 1959.

His career in public office began with his election to the Iowa State Legislature in 1932, where he served for more than 30 years maintaining a party leadership position most of the time. He was House majority floor leader for three sessions and served as speaker pro tempore during one session.

Throughout his career, the funding and administration of state road programs had been a principal interest, and he was a strong influence in the development of farm-to-market roads. He was known as an Iowa Constitutional expert and was widely respected for his knowledge and authority on the State Code. He had more seniority than any other legislator currently serving.

He was preceded in death by his parents, three sisters and six brothers.

He is survived by his widow, Ione; two sisters, Mrs. Dessie Shields of Bloomfield and Mrs. Dimple Campbell of

Sebastopol, Calif; three brothers, Dean M. and Doran B. Goode of Bloomfield and Dr. DeWitt V. Goode of Bondurant, and many other relatives.

Funeral services were held Wednesday, March 29, 1972, at the Priester Funeral Chapel, Bloomfield, Iowa, conducted by the Rev. Galen Peckham. Interment was in the IOOF Cemetery, Bloomfield, Iowa.

Lena Ann Selix

Funeral services for Mrs. Lena Ann Selix were held March 15, 1972, at the Wagler Funeral Home, Bloomfield, Iowa, conducted by Jerry Weller, Minister of the Orleans Church of Christ.

Mrs. Selix was born in Davis County January 28, 1922, to George and Lena Horn Gravett. She died March 13, 1972, at the Davis County Hospital following a lengthy illness. She was 50 years, one month and 14 days old.

She was united in marriage to Francis Selix January 14, 1944. To this union were born two daughters.

Mrs. Selix was a life-long resident of Davis County and was an elementary school teacher for 20 years, most of the time in the Davis County Community School system. She was a member of the Orleans Church of Christ.

She is survived by her husband, Francis, two daughters, Mrs. Jayne Anne Voyce and Mrs. Linda Trogden both of Des Moines; two grandchildren, two sisters, Miss Leta Gravett of Des Moines and Mrs. Freda Duckworth of Indianola and one brother, Glen Gravett of Moulton.

A memorial in her memory has been established for the Orleans Church of Christ.
