Gustav Kuester, Former Iowa Legislator, Dies

Gustav T. Kuester, 92, former speaker of the Iowa House of Representatives, died Sunday at the Griswold Care Center, where he had been a resident since 1972.

He was born Jan. 25, 1888, the son of Charles and Cathryn E. Abhan Kuester. He attended rural schools in Noble Township, where he was a lifetime resident. He was married to Elda G. Weaver on April 4, 1971, at the Noble Center Parsonage.

In 1932 Kuester was elected to the Iowa House of Representatives as representative from Cass County, serving until 1954. He served in 11 regular and three special sessions of the legislature, and was speaker of the Iowa House for four years during the 52nd and 53rd General Assemblies.

He was a lifetime member of the Noble Center United Methodist Church and served on the church board of trustees. He also served on the board of directors of the Noble Township Insurance Association, as clerk of Noble Township and on the board of directors of the Atlantic Memorial hospital.

Surviving are a son, Dale of Griswold; a daughter, Mrs. Merrill (Shirley) Coon of Ankeny; two granddaughters, Mrs. David (Kathy) McCullar of Louisville, Kan., and Lori Kuhn of Estes Park, Colo.; and a brother, Carl of Griswold.

He was preceded in death by his parents, his wife in 1978, four brothers, Bertie, Lewis, Adam and George; four sisters, Mary Kuester, Bertha "Fillie" Metzger, Emma Barnes and Cathryn "Fena" Scharf.

Funeral services will be held at 10 a.m. Wednesday at the Wagler Funeral Home in Griswold, with the Rev. Richard Fitch officiating. Burial will be in the Noble Center Cemetery.
