**Final Rites
For Maniece
On Thursday**

Last rites for Edward J. Maniece, 74, who died yesterday at 10:40 a.m. at Holy Family Hospital after having been admitted only a short time before, are to be Thursday at 2 p.m. in First Presbyterian Church, the Rev. H. Allen Wirtz officiating. His death was attributed to a heart attack.

Burial services for Mr. Maniece will be conducted at Oak Hill Cemetery. The church service will be preceded by a family service to be held at 11 a.m. at Fuhrman Funeral Home. Friends may call at the funeral home until 11 a.m. tomorrow at which time the body will be taken to the church where friends may call until time of services there.

Honorary pallbearers are to be Harry Peterson, Walter A. Schultz, Clarence O. Anderson, Lynn Weir, Joy R. Horswell, William S. Clark, Dr. Archie Whitlow, Merl Landmesser, Dr. Leland Bunge, Milton J. Larson, Elmer Chambers and R.S. Knight.

Active pallbearers are Maurice Juhl, James Eckard, Harold Lange, Edwin Christensen, Earl W. Stiek and Walter Frick, all neighbors of Mr. Maniece.

Mr. Maniece, a prominent farmer of Emmet County served the county and his community in many areas during his lifetime, having been a member of the Iowa State Legislature from 1932-1938, secretary of the Emmet Consolidated School board from 1921-1936, a Farm Bureau past president, member of the BPO Elks, member of the Knights of Pythias Lodge for more than 50 years, where he had been past chancellor commander and had served as grand chancellor of the State of Iowa in 1919 and 1940. He was honored recently and awarded a 50-year pin by the Knights of Pythias. He served Emmet Township as assessor for 11 years.

He was a democrat and took an active part in the party's interests both at a county and state level.

In addition to his other activities, Mr. Maniece helped set up the first Emmet County Selective Service program under the draft law in 1940 and had served on the board continuously since that time. Two years ago he was awarded a 20-year service pin and certificate for his long tenure.

Edward Maniece was born at Fennimore, Wis., on March 16, 1890, the son of Frank and Ellen Maniece. He received his education in Estherville and graduated from the former Estherville Business College in 1908.

He was married Nov. 3, 1917, to the former Anna Stammer of Estherville.

Mr. Maniece came with his father to Estherville when only a year old and until 1917 worked with his father on their farm north of Estherville. Since his father's retirement, he had

**Heavy Rains Lash
West for 3rd Day**

Gale-whipped torrential rains from the Pacific lashed California, Oregon Idaho and Nevada today for the third straight day, endangering scores of cities and towns and threatening to force evacuation of a city of 11,000.

The Christmastime deluge has killed six persons, left three rescuers missing and forced more than 5,000 persons to flee before raging waters of a dozen flood-swollen mountain rivers and hundreds of streams.

An amphibian helicopter carrying three Coast Guardsmen was missing and presumed down after evacuating 10 persons from an island in California's Eel River.

At Yuba City, Calif. 110 miles north of San Francisco, the Sutter County Board of Supervisors made a provisional decision to evacuate the city's 11,000 persons if and when the Feather River reaches 77-foot depth. The river was expected to reach 79 feet this afternoon.

The river is backed up behind a levee. In the disastrous 1935 Northern California flood, 38 persons died when the levee washed out and the river reached 82.6 feet.

Rampaging flood waters have forced evacuations in Guerneville, Orick, Fortuna Klamath, Loleta, Paskenta, Scotia, Rio Dell, Pepperwood, Weott, Myers Flat, Phillipsville and Miranda in Northern California.

The evacuees found shelter with luckier neighbors, in nearby towns, hotels and in emergency lodgings set up by Civilian Defense and Red Cross.

A provisional decision to evacuate the 11,000 residents of Yuba City, Calif., was made today by the Sutter County Board of Supervisors. The order to evacuate will be given if and when the Feather River reaches 77 feet, supervisors said.

LOS ANGELES (AP) — If you have more money than ideas left over from Christmas shopping and still can't find something for someone who has everything, try gathering complete props for the carol, "The Twelve Days of Christmas."

Don't rush in blindly, because this gift costs to the tune of five figures. But you could be the only one on your block to bestow such a remembrance.

Forthwith, then, the instructions:

"On the first day of Christmas, my true love gave to me, partridge in a pear tree," goes the first verse.

In Los Angeles, the going price for an evergreen bird is enough for a partridge perch is \$300. Live partridges go for \$10 a pair but you only need one.

After getting the basic prop, the pear tree, you need:
