# Paul Millhone, Long-Time Attorney, Dies at Clarinda

Paul L. Millhone, 77, former state legislator and long time attorney in Page County, died Friday at West Heights Manor in Clarinda following a long career of civic service.

Funeral services will be held at 4 p.m., Tuesday from the Westminster Presbyterian Church in Clarinda with burial in Clarinda cemetery. The Rev. D.C. Davis will officiate. The casket will be open previously at the Lavelle Funeral Home. It is the family's preference that memorials be made to Simpson College or to the Clarinda Community College Corporation.

Survivors include his wife, the former Margaret Griffith; two sons, John Paul Millhone of Des Moines and James N.

Millhone of Clarinda; three daughters, Martha Mary Smeltzer, Davis, Calif.; Margie Ruth Williams, Cody, Wyo.; Alice D. Fountain, Peekskill, N.Y. Also surviving are a brother, Frank, of Clarinda and seven grandchildren.

Millhone served in the Iowa House of Representatives from 1931 to 1934 and in the Iowa Senate from 1935 to 1938.

He practiced law for nearly half a century in Page County, beginning with the firm of Wilson and Keenan in Shenandoah in 1922. He was elected county attorney in 1925 and moved to Clarinda that year. After serving six years in that capacity, he became a partner in the law firm of Stevens, Thornell and Millhone in 1931.

Millhone had served as member and president of the Clarinda school board, served a term as president of the Iowa Association of School Boards and for more than 20 years was a board member of Blue Cross of Iowa. He served a term on the Clarinda library board, was a past president of Kiwanis and the Clarinda Chamber of Commerce and held memberships in the Masonic lodge there, Alpha Tau Omega social fraternity, Pi Delta Pi legal fraternity and the Westminster Presbyterian Church.

Born Dec. 8, 1892 in Page County, the son of Mr. and Mrs. Isaac Millhone, he attended schools in the area and received his AB degree from Simpson College, Indianola, in 1917. For two years during World War II, he taught at Kemper Military Institute in Booneville, Mo. He graduated from Western Reserve University law school, Cleveland, O., in 1922. He was married to Margaret Griffith of Des Moines in 1926.

F. BRITTON LANGDON, a Des Moines physician, an obstetrician, was born in the state, and brought to his work thorough education and exceptional natural qualifications.

Doctor Langdon was born at Rippey, Iowa, March 24, 1890, son of Daniel B. and Clara (Taylor) Langdon, his father a native of Cloverdale, Indiana, and his mother of Illinois. His grandfather, Britton Langdon, was a native of South Carolina, moved to Indiana, and spent his last years in Missouri. He was a lawyer by profession and was judge of the District Court when he died. The maternal grandfather was Samuel Taylor, who was born on Lake Erie in Ohio, moved out to Illinois and later to Iowa, where he followed farming. Daniel B. Langdon was educated in normal schools, was a teacher for fifteen years, and is now in the school supply business. His wife died in 1914. They were members of the Christian Church, and he was a Democrat in politics. Dr. F. Britton is the oldest of three children. His brother, F. V. Langdon is postmaster of a sub-station in Minneapolis, and John is an expert oil well shooter, living at Great Falls, Montana.

F. Britton Langdon acquired most of his early education at Minneapolis, graduating from high school in 1908, and in 1912 took his Bachelor of Science degree from the University of Wisconsin, where he pursued his pre-medical course. In 1915 he graduated from the Illinois Medical College of Chicago, and for six months was an interne in the Chicago Lying-in Hospital, and after coming to Des Moines had another year of interne service in the Des Moines Methodist Hospital. He has been in practice since 1916, and a large part of his work has been in the field of obstetrics. He is a member of the Polk County, Iowa State and American Medical Associations.

Doctor Langdon married, in 1912, Charlotte L. Lovejoy, a sister of Dr. E. P. Lovejoy. Mrs. Langdon is a member of the Church of Christ. He is a Scottish Rite Mason and Shriner, is a member of the Phi Rho Sigma medical fraternity and the Sigma Nu social fraternity. In politics he acts independently.

PAUL L. MILLHONE, county attorney of Page County, was born on a farm near Clarinda, December 8, 1892. He represents some of the old and substantial families of Southwestern Iowa. His father is a highly respected farmer of Page County, and Paul has been steadily accumulating good will ever since his boyhood days in this community, and his personal popularity is supplemented by an exceptional degree of sound ability in his profession.

His parents are Isaac N. and Flora (Wymore) Millhone, both of whom live at Clarinda, while Mr. Millhone operates his farm at the edge of the city. He was born in Henry County, Iowa, and the mother near Oskaloosa. The paternal

grandfather was Lambert Millhone, a native of Guernsey County, Ohio, who came to Iowa and settled in Henry County in the early days and later moved to Page County, where he bought land when it was cheap and acquired a considerable amount of property. He died in 1922. Isaac Millhone is a Republican in politics and a member of the Masonic fraternity, and his wife belongs to the Presbyterian Church. They have two sons: Frank D., a farmer near Clarinda, and Paul L.

Paul L. Millhone after attending school at Clarinda entered Simpson College at Indianola, Iowa, and graduated with the A. B. degree from that school in 1917. During the World war he failed to get accepted for active duty because of an injury to his hand, received in a football game. For two years during the war period he acted as an instructor in the Kemper Military Academy at Boonville, Missouri. Mr. Millhone in 1922 was graduated from the law department of Western Reserve University at Cleveland, Ohio, and at once returned to his native county and began practice at Shenandoah, associated with the law firm of Wilson & Keenan. In 1925 Mr. Millhone was elected county attorney of Page County, and is now in his sixth consecutive year in that office, to which he devotes his full time, and has the 1930 Republican nomination for state representative. He is a member of the Page County, Iowa State and American Bar Associations and a Republican in politics.

Mr. Millhone married, June 26, 1926, Miss Margaret Griffith, who was born at Creston, Iowa. Her father, Rev. A. E. Griffith, is a retired minister of the Methodist Church, now living at Des Moines. Mrs. Millhone is a Methodist, while he belongs to the Presbyterian Church. She is a member of the Phi Beta Phi sorority, and his fraternal affiliations are with the Phi Delta Phi law fraternity, the Alpha Tau Omega, and the Royal Arch Masons. Mr. and Mrs. Millhone have two daughters, Martha Mary, born September 7, 1927, and Ruth Marie, born February 4, 1930.

THOMAS LINCOLN EVANS, retired coal operator, is a resident of Albia and has lived nearly all his life in Iowa. He has been an exceptionally successful business man, and at all times a generous and public spirited citizen.

Mr. Evans was born in Ohio, April 14, 1865. His birthday was also the day on which Lincoln was assassinated, and it may be recalled that this date was also Good Friday. The following year, 1866, his parents came out to Iowa and located in Mahaska County.

Mr. Evans is a son of Christmas and Emily (Edwards) Evans. His father was a native of Wales, and came to this country about the time of the American Civil war. When General Morgan made his famous raid through Southern Ohio he captured Christmas Evans, who proved somewhat of a burden on the hands of the raiders, since he could not understand their language and none of the captors understood his. Finally they ran across a Welshman who was able to

and was incorporated in the latter year. Mr. Fredericks employs eleven persons in Hill and Fredericks, with Cadillac cars and hearses. Two of the employees maintain quarters on the second floor of the funeral home so that someone is always in the two buildings twenty-four hours a day.

The chapel in Mr. Fredericks' mortuary, softly lighted and equipped with solid walnut pews on its main floor and balcony and carpeted throughout, seats more than two hundred persons. The entire funeral home abounds in paintings. One, in the chapel, depicting Jacob's ladder and one on the landing of the main reception hallway, "Christ on Gethsemane," done by Carson, are greatly admired by art critics. There are numerous others by Dr. Kuno Struck, deceased, well-known Davenport physician and painter. On either side of the entrance to the chapel are two small rooms provided for those who wish to wait before entering the chapel proper. The family room, reception rooms, and slumber rooms are furnished luxuriously and give the appearance of a private home. A successful attempt has been made to dismiss the things that might suggest morbidity and the interior of the establishment is full of charm and dignity. Besides two slumber rooms for adults, a child's room, done in pink, blue, and cream, has been provided. The offices are also on the ground floor. Upstairs are a laboratory, a large casket room, a wardrobe room where slumber garments may be purchased, and quarters for the resident attendants. The firm is associated with the National Selected Morticians, an invitational society.

Mr. Fredericks is a member of such Masonic bodies as the Ancient and Accepted Scottish Rite, the Royal Arch Masons, and Kaaba Temple, Ancient Arabic Order of Nobles of the Mystic Shrine, in Davenport; of the Davenport Lodge, Benevolent and Protective Order of Elks; the Knights of Pythias; the Loyal Order of Moose; the Rotary Club of Davenport; the Davenport Club; the Outing Club; and the Rock Island Golf Club. He is a member of St. John's Methodist Church of Davenport.

George H. Fredericks married Jessie P. Marsh of Davenport. Mrs. Fredericks, whose family came to Iowa from the East, was educated at Syracuse College. Mr. and Mrs. Fredericks have two daughters: Emilie, born on June 14, 1928, who, after completing her early education in Davenport's elementary and high schools, entered and was graduated from the State University of Iowa; and Carolyn Jane, called Jane, born on January 20, 1933, who, in 1948, was in high school in Davenport. Mr. Fredericks' office address is 1229 Brady Street, Davenport.

**KENT H. THORNELL**—The city attorney of Clarinda, seat of Page County, is Kent H. Thornell, an outstanding member of the legal profession in southwestern Iowa. Mr. Thornell, who is a member of the law firm of Stephens, Thornell and Millhone of Clarinda, is also active in farming and livestock production. A veteran of World War I, he has long taken a leading part in the activities of ex-service men.

Born in Sidney, seat of adjoining Fremont County, Kent H. Thornell is the son of the late Judge A. B. Thornell and Olive B. (Gray) Thornell. His father was one of Iowa's most renowned citizens. A native of the area near Rochester, New York, A. B. Thornell settled in Iowa at an early age, and like his son was a lawyer. He practiced at Sidney. He served as judge of the Fifteenth Iowa Judicial District for thirty years. Prior to his elevation to the bench he was a

district prosecutor. Judge Thornell resigned from the bench in 1917, when he returned to the practice of law as the partner of his son. This was in Sidney, where he remained until his death in February, 1932, at the age of eighty-six. Mrs. Olive Thornell, his wife, a native of Fremont County, near Sidney, had died in 1927, at the age of seventy. Clarinda's city attorney had three brothers: Dr. Joseph B. Thornell, who died in May, 1949, at Council Bluffs, where for many years he had practiced as a physician and surgeon; Judge Andrew V. Thornell, who died in 1944, and Major John G. Thornell, of the Regular United States Army, who was killed in 1922.

Kent Thornell grew up in Sidney. He was graduated from the high school there in 1910 and then went to the University of Nebraska, at Lincoln, after which he continued his education at the University of Michigan, Ann Arbor. He began his legal studies at Michigan, but completed his education and professional training at the State University of Iowa College of Law in Iowa City. He received his degree of Bachelor of Laws in 1917. In May, 1917, a month after the United States declared war on Germany and the other Central Powers, he entered the United States Army. After a period in an Officers' Training School, he was commissioned a second lieutenant. By the time he was honorably discharged, January 6, 1919, he was a first lieutenant. On his return home, he gained admission to the Iowa State Bar and in July, 1919, he began his partnership with Homer S. Stephens. In 1931, Paul L. Millhone joined the firm, which became known by its present name, Stephens, Thornell and Millhone. The firm's offices are in the Hawley Building, 113½ East Main Street, Clarinda.

Mr. Thornell rapidly established a reputation in the law as well as in civic endeavors. He became a leader in veterans' affairs and served as commander of the Sergy Post No. 98, of the American Legion, in Clarinda and for some years now he has been city attorney. His farm is in Taylor County, where in addition to growing crops he handles beef cattle and butcher hogs. He is a member of the Page County, Southwest Iowa and Iowa State bar associations, Phi Gamma Delta and Phi Delta Phi fraternities, the latter a legal organization; the Masonic order and the Clarinda Country Club. He is a Presbyterian and Republican. Farming and the law are his hobbies. His home is at 402 West Clark Street, Clarinda.

Mr. Thornell married Helen Hill of Hamburg, Iowa, on March 28, 1917. Mrs. Thornell's parents were Frank W. and Katherine (Hydinger) Hill. Her father, a native of Sidney, was for years a druggist at Hamburg, where he still resides and where in 1949 he celebrated his eighty-fourth birthday. Her mother, born in Hamburg, died there on September 21, 1948, at the age of seventy-nine. Mrs. Thornell is a member of the P. E. O. Sisterhood and various other women's organizations in Clarinda. A daughter, Elaine, was born to Mr. and Mrs. Thornell on October 22, 1910. She is now the wife of John Duckwall of Mount Vernon, Iowa, where he is director of the bands of Mount Vernon High School and Cornell College. Mr. and Mrs. Duckwall have a son, John Andrew, who was born on July 15, 1947.

**PAUL L. MILLHONE**—Service as county attorney of Page County, as a member of first the State House of Representatives and then the State Senate, and as head of civic organizations and member of school and hospital boards has made Paul L. Millhone

of Clarinda, seat of Page County, one of the leading figures of the state. Prominent in the bar, he has been a member of the law firm of Stephens, Thornell and Millhone, of Clarinda, since 1931.

Mr. Millhone was born on his father's farm in Page County on December 8, 1892. His parents are Isaac N. and Flora (Wymore) Millhone, the former a native of Henry County, the latter of Oskaloosa, Iowa. Until he and his wife moved to Clarinda, in retirement, the elder Mr. Millhone was a farmer and stockman in Page County.

The lawyer, brought up on the farm, began his education in the nearby rural schools. As part of his prelegal preparation, Mr. Millhone attended Amity College at College Springs, Page County, and following his graduation from that institution entered Simpson College at Indianola. In 1917, he was awarded the degree of Bachelor of Arts at Simpson and in the next two years he taught at the Kemper Military School, Booneville, Missouri. Finally, he prepared for the bar at Western Reserve University College of Law in Cleveland, Ohio, where in 1922 he took the degree of Bachelor of Laws.

Returning to Iowa, he won admission to the State Bar and began practice at Shenandoah, Page County's largest city. He was with the law firm of Wilson and Keenan in Shenandoah from 1922 to 1924. In that short period he achieved such prominence in the profession and in public affairs as to be elected to the office of county attorney. This required his removal to the county seat, Clarinda, where he served three terms, or six years, as county attorney. In November, 1930, he was elected to the State House of Representatives at Des Moines. Here he served two terms, or four years, following which he was sent by the people to the State Senate, where he served one four-year term. In the course of his service in the legislature, Mr. Millhone joined the firm of Stephens, Thornell and Millhone, with offices in Clarinda. His partners are Homer S. Stephens and Kent H. Thornell, both of whom are subjects of biographies appearing separately in this history of Iowa.

In the years since then Mr. Millhone has crystallized his reputation as lawyer and public citizen. He has served as president of the Kiwanis Club of Clarinda, of the Clarinda Chamber of Commerce and the Clarinda Country Club, and is now serving on the Clarinda Board of Education and the board of directors of the Clarinda Hospital Association. In addition, he is an elder of the Presbyterian Church. He has farming interests in Taylor and Page counties. The professional organizations to which Mr. Millhone belongs include the Page County, Southwest Iowa and Iowa State bar associations, Alpha Tau Omega, the social fraternity, and Phi Delta Phi, the legal fraternity. Also, he is a member of the Masonic Blue Lodge in Clarinda and the Order of the Eastern Star. He is a Republican.

Mr. Millhone married Margaret Griffith, the daughter of the Reverend A. E. and Mary (Dudley) Griffith, on June 26, 1926. Her father, a Methodist minister, died in 1946, at the age of eighty-nine. Her mother died in 1933. Mrs. Millhone is active in various women's organizations, including the P. E. O. Sisterhood and the Daughters of the American Revolution. She and Mr. Millhone have five children: Martha Mary, born on September 7, 1927, graduated from Simpson College in 1948 and now (1949) doing graduate work; Margie Ruth, born February 4, 1930, studying at the University of Wyoming, Laramie; John

Paul, born on November 15, 1931, a senior in high school in Clarinda (1949); James Newton, born on February 14, 1937; and Alice Dudley, born on October 24, 1941. The family residence is at 223 West Garfield Street, Clarinda.

**HOMER SHERMAN STEPHENS**—The law firm of Stephens, Thornell and Millhone of Clarinda is renowned in Southwestern Iowa. Each of its partners has, in his own way, contributed in distinguished fashion to the progress of the city, region and state and the firm as a whole has done much to elevate the standards of legal practice and to advance the cause of justice. Homer Sherman Stephens, who preceded his partners in the practice of the profession, has a statewide, even a national reputation, as a Republican leader, has served on bodies promoting educational developments and good roads and participated in important civic movements. Also, he is a former city solicitor of Clarinda and former county attorney of Page County, of which that city is the seat.

Mr. Stephens, the son of Joseph F. and Mary C. (Keller) Stephens, was born on a farm near Sidney, the seat of Fremont County, on November 8, 1883. He was graduated from high school in 1904 and then attended the University of Nebraska, at Lincoln, where in 1908 he took the degree of Bachelor of Arts. For his legal studies Mr. Stephens went to the University of Michigan, at Ann Arbor, which in 1910 awarded him the degree of Juris Doctor. In his college days he was elected to Delta Upsilon, the social fraternity, and to Phi Delta Phi, the legal.

In 1910, Mr. Stephens was admitted to the Iowa and Michigan State bars and in 1911 to the Colorado State Bar, and from 1910 to 1913 he practiced his profession in Fort Collins, Colorado. In 1914, he returned to Iowa and established himself in practice in Clarinda. Soon a leader in the profession and in public activities, he was named city solicitor and, subsequently, county attorney of Page County. In 1919, Mr. Stephens and one of his present partners, Kent H. Thornell, formed a law partnership. In 1931, they took Paul L. Millhone into the firm, and today the partnership is known as Stephens, Thornell and Millhone. Its offices are at 113½ East Main Street, Clarinda.

Mr. Stephens' activities in politics brought him election as chairman of the Page County Republican Central Committee, of the Republican Central Committee of the Seventh and Eighth Iowa districts and chairman of the Iowa Republican Central Committee in 1932. In 1924, he was a delegate from Iowa to the Republican party's national convention in Cleveland, Ohio. He remains a leading figure in the party. He is a member and president of the Page County Board of Education and is a former director of the Iowa Good Roads Association. He is also a former president of the Page County Bar Association and a former director of the Iowa State Bar Association. In addition, he is active in the Bar Association of the Fifteenth Judicial District of Iowa. He has served as president of the Kiwanis Club of Clarinda, and is also a member of the Clarinda Chamber of Commerce, the Clarinda Country Club and various Masonic bodies, including Clarinda Lodge No. 140, Ancient Free and Accepted Masons, and Clarinda Chapter No. 29, Royal Arch Masons, Knights Templar, and of the Independent Order of Odd Fellows. Hunting, fishing, golf and travel have been his favorite recreations. His home is at 132

He was active in the Republican Party and served in the House of Representatives in the Forty-fifth, Forty-fifth Extra, Forty-sixth, Forty-sixth Extra, Forty-seventh, Forty-eighth and Fifty-sixth sessions of the General Assembly. He was elected to the Senate in 1944 and served there in the Fifty-first, Fifty-second, Fifty-third and Fifty-fourth sessions of the General Assembly. He was a Pioneer Lawmaker and served as vice president of this organization.

Mr. Hultman served as mayor and councilman of Stanton, was vice-president of the Houghton State Bank of Red Oak, Iowa; he served in the army in World War I and was a Charter and Fifty-year member of the Ernie Johnson American Legion Post; he was a member of the Za-Ga-Zig Shrine Temple; a thirty-second degree Mason and had been a Mason for fifty years; he was also a member of Knights of Pythias.

Mr. Hultman passed away September 14, 1969 at his summer home, a ranch near Moose, Wyoming. He is survived by his widow; two sons, Donald of Bellevue, Washington, and Calvin of Red Oak, Iowa, and three granddaughters.

#### PAUL LAMBERT MILLHONE

MR. PRESIDENT: Your committee, appointed to prepare a suitable resolution commemorating the life, character and public service of the late Honorable Paul Lambert Millhone, begs leave to submit the following memorial:

Paul Lambert Millhone was born in rural Page County, Iowa, on December 8, 1892, the son of Isaac Newton and Flora Wymore Millhone.

In 1931 he was one of the few Republicans elected to the House of Representatives. He was a member of the House until 1934, at which time he was elected Senator from Page and Fremont Counties, and continued to serve in the Senate until 1938.

Paul Millhone was a long time Clarinda attorney. During his lifetime, he was a leader in his community and throughout the State. His death occurred on June 26, 1970.

For nearly a half century he practiced law in Page County. He initially started the practice of law with the firm of Wilson & Keenan in Shenandoah

in 1922, and in 1925, when he was elected Page County Attorney, he moved to Clarinda, where he lived for the remainder of his life.

As a legislator and attorney, it was his conviction that the purpose of the law was to serve the people. He lived his life with the same conviction. He served his community and his state with a constant effort to maintain the welfare of the people in that community and state.

He was for many years a member of the School Board of the Clarinda Community School District. He also served for many years as a director of the Municipal Hospital in Clarinda.

Upon graduating from Simpson College, Mr. Millhone taught two years during World War I at Kemper Military School in Missouri. In 1922 he graduated from Western Reserve University Law School, Cleveland, Ohio, with a Juris Doctor Degree.

On June 26, 1926, he was married to Margaret Griffith of Des Moines, Iowa. Five children were born to this union. At the time of his death, Mr. Millhone was survived by his wife, Margaret; his brother, Frank, of Clarinda; three daughters, Martha Mary Smeltzer of Carmichael, California; Margie Ruth Williams of Cody, Wyoming; and Alice D. Fountain of Worthington, Ohio; two sons, John Paul of Des Moines, and James N. of Clarinda; and seven grandchildren, Paul, Kirk and Mark Millhone, Peter and David Williams, and Robert and Patricia Fountain.
