George was a farmer for several years, specializing in Holstein cattle. In 1920 he was living in northeastern Johnson county, and was a pumper for a steam railroad. Worked for Rock Island railread 4years. Was a mail messenger in Independence for 15 years, carrying mail from depot to post office--in this position in 1937. Also operated a taxi service in Independence.

Apparently no children. Burial of George and his wife, and Alexander and Mary Ann, not found in listings in Independence or Quasqueton cemeteries.

## 2 Townships To Have New Fire Trucks

*Liberty and Homer  
Expecting Delivery  
Early in November*

Two Buchanan county townships—Liberty and Homer—are scheduled to put new fire fighting equipment into operation in November.

Quasqueton Fire Chief Harry Johnson announced this week that Liberty township has purchased a new \$11,000 fire truck from the Fire Fighter Truck Co. of Rock Island, Ill. It is expected to be delivered about Nov. 1, the same date set for the delivery of Homer township's new equipment by the same company.

Liberty township's new fire-fighting equipment will be housed in the remodeled fire station at Quasqueton. The new apparatus includes a 650-gallon water tank and a total of 1,100 feet of regular and high-pressure hoses.

Bonds for purchasing the equipment were bought by the Waterloo Savings bank at 3½ per cent interest.

In August, Homer township purchased fire-fighting equipment from the Rock Island firm to be mounted on a Ford truck chassis. Liberty township's equipment will be mounted on an International chassis.

Mr. Hathaway, son of Alexander and Mary Hathaway, was born May 7, 1873, in Independence. He was a farmer for several years, specializing in Holstein cattle. He served as a mail messenger in Independence for 15 years carrying mail from the railroad depot to the post office on a contract.

He was a member of the state legislature in the 47th and 48th General assemblies. He also conducted a taxi business here several years ago. He married Clara Ryan in Independence in 1908.

The body is at the People's Funeral home in Independence where final arrangements are pending.

Attended rural schools and Iowa City grade schools, Iowa City academy, graduated from the State University of Iowa medical college in March, 1899. Served in the Spanish-American and World war; over seas ten months. At present colonel, medical officers reserve corps. Located in Lisbon, Iowa, in March, 1900. Married April, 1905 to Pearl O. Smith and they have three children. Member and trustee of Methodist church. Member of I. O. O. F., Masonic lodge, including Scottish Rite and Shrine, drum major of El Kahir Shrine band. DEWEY E. GOODE, Bloomfield.—Representative from Davis county, was born in Bloomfield, Iowa, June 2, 1898, the son of L. E. and Rosa Goode. He was educated in the public schools of Bloomfield and was married in 1917 to Miss Ione McIntire. The first two years after his marriage he resided on a farm in Davis county, and then went back to Bloomfield to help his father in the produce and fur business, and he has continued in the same business up to the present time. Serving his third term in the legislature. A republican.

GEORGE W. GROVES, Webster City.—Representative from Hamilton county, was born November 2, 1872, on a farm in Hamilton county which he now owns. Was educated in the rural schools and has always operated his own farm. Son of Jackson Groves who came to Iowa from Virginia and Jane Dressler Groves who came from Pennsylvania both in the early sixties. Married in 1893, to Mary A. Branch to whom was born three daughters and one son. Has always been interested in cooperative movements not only of farmers but of farmers and business men.
