Earl C. Fishbaugh, Jr., Dies At Office Desk

Earl C. Fishbaugh, Jr., 59, died suddenly at his law office Friday Feb. 14 at 5:15 p.m.

Mr. Fishbaugh had been active all day and had returned from business at Hamburg. He was talking on the phone at the time of an aortic rupture.

During the telephone conversation the client with whom he was speaking heard the clatter of the telephone falling and then silence. The client broke the connection, called the operator and reported the situation. The operator began an investigation which ended in finding Mr. Fishbaugh lying beside his desk.

Mr. Fishbaugh was prominent in Iowa politics and had served five terms in the House of Representatives and two terms in the Senate. He retired from active politics in 1955 but still continued his interest in political affairs.

During the last few years he has served as city attorney.

A graduate of the University of Nebraska he belonged to a number of clubs and organizations including Delta Theta Phi legal fraternity, Masons, Eastern Star, Kiwanis, American Legion and other groups.

He was a director and bank attorney for the Security Trust & Savings Bank.

He is survived by his wife, Esther, and one brother, Robert.

Funeral services will be held at the Presbyterian Church Tuesday Feb. 18 at 2:30 p.m. The Rev. Davis B. Cecil and the Rev. Walter H. Miller will conduct the service.

A memorial fund is in charge of Mrs. Dale Livingston.

Fines Instead Of Warnings To Shoplifters

A "get-tough" policy on shoplifters has been enacted at Gibson's Discount store recently. According to Eddie Cochran, assistant manager, the policy is paying off with 16 shoplifters being caught in the last 8-day period.

Saturday, a woman and three children were apprehended in the store, all with merchandise on their persons. The 12-year-old boy had two bottles of men's after shave in his rear pockets. One girl, 13, had false eye lashes, eye make-up and other beauty products in her purse. The third child, a 10-year-old girl, had a flour sifter, nail clippers, pencil sharpener and eye make-up. The mother had men's hair conditioner, hair dressing, a bottle of Geritol and a bar of soap in her purse. The woman's husband was waiting outside in a car, according to Cochran.

Charges were pressed and the woman was fined. Juvenile reports were filed on the children.

Cochran stated, "Up until recently, we have let most shoplifters off with a warning. Now we plan to file charges on all we catch."
