Education Plan Would Set State Standards For

what students should know and be able to do. One example of a potential outcome is that each student would be able to read, write, speak and listen and to use math and foreign language skills in ways similar to what he or she would encounter in life.

Each school district would be responsible for defining more specific outcomes based on the community's expectations for students, according to the plan.

Other priorities outlined in the plan include developing a system to assess how well students are meeting the outcomes and providing teachers with time and training to change schools so that they focus on the outcomes. In addition, the plan outlines the State Board's support for improving deteriorating school buildings, expanding the use of technology in schools, bringing Iowa's educator salaries to at least the national average, and recruiting a more culturally diverse educational work force.

The State Board also approved a legislative agenda for 1992 that supports:

- maintaining adequate funding for elementary/secondary education, area education agencies and community colleges.

- providing grants to nonprofit community organizations for programs to encourage minority students to attend college.

- altering Iowa's open enrollment legislation to allow students to be eligible for athletics 90 days after transfer from one school district to another.

- creating a method for schools and school districts to use non-traditional approaches to education to improve student achievement.

Report Projects Billion Dollar Deficit, High Taxes

Iowa's budget deficit could swell to \$1.5 billion a year and Iowans could be paying 42 percent more in personal income taxes just to eliminate that deficit in 15 years, if state government continues down its current budget path.

These are among significant findings in a report released by the Iowa Group for Economic Development, a bi-partisan confederation of 50 business leaders from across the state.

The Iowa Group commissioned KPMG Peat Marwick's Policy Economic Group of Washington, D.C. to analyze Iowa's present fiscal condition and project costs of government into the future with the impact on Iowa taxpayers.
