Served in Army as Ambulance Driver, 4th Div. was gassed and wounded in action. Was superintendent of schools 15 years, at Elma, Manly and Atlantic. For 15 years owned Bill Tate Realty Co., in Mason City, and was general agent for American Mutual Life Insurance Co.

Resigned Senate Seat, in 1957, to become Real Estate Officer for Western Iowa and Northwest Missouri, for U. S. Post Office. Was planning to return to Mason City real estate, insurance business, at time of death.

Helped pass law giving property tax exemption to Korean vets.

Oldest of 9 ch; he was survived by mother, wife, his five children, 4 brothers, 2 sisters, and 7 grandchildren.

One history of Tate family, which does not connect to him, says Tates found in England in 9th Century; name is from Norwegian, meaning "younger" or "son of". A Tate came to Va 1635. Some Va family Tates were in Iowa by 1900.

**Former Senator**

**William Tate Dies at 59**

William H. (Bill) Tate, 59, Mason City man who has been a real estate officer with the U. S. Post Office Department, died early Sunday at a Des Moines hospital. He had been ill for eight months.

Tate was state representative for Cerro Gordo County from 1950 to 1956 and state senator from this district from 1956 to 1957. He resigned as senator in 1957 to become real estate officer in western Iowa and northwest Missouri for the Post Office Department.

Tate and his wife had been living in Des Moines in connection with his federal work but were planning to return to Mason City. While here he had operated a real estate and insurance business for more than 15 years. Tate's Mason City home was at 202 Virginia S. E. before he went to Des Moines.

**TATE WAS a lifelong resident of Iowa.** Reared at Independence, he holds a bachelor's degree from Upper Iowa University and a master's degree from the University of Iowa. He was at one time superintendent of schools at Elma, Manly and Atlantic. He was from a family of athletes.

He was born at Independence Aug. 11, 1900. He served in the Army in World War I and was gassed and wounded in action.

In the Iowa House Tate had such important committee appointments as chairman of the Public Lands and Buildings Committee, Schools, Appropriations, Cities and Towns, Insurance, Public Health and Pharmacy, Mines and Mining and other committees. In his final

**One Tool We Refuse to Use**

**I CAN'T THINK OF ANY** thing more discouraging in my 30 years of contact with the organized safety movement in America than our refusal to face up to the fact that alcohol is killing thousands of people on our streets and highways.

I say "our refusal" because we are a practicing democracy. What has happened — or, more accurately, what hasn't happened — is a reflection of popular opinion. We aren't cracking down on drunken drivers for one over-all reason. The public just isn't for that course of action.

We have several forms of scientific tests for the determination of intoxication. They are almost as infallible as the fingerprint test which has been a recognized part of crime detection for a century or so. Each year sees a little extension of these tests but we move forward grudgingly. Why?

Is it because so very many of those who make up the American public are imbibers themselves and therefore afraid that strict enforcement of the law against driving after drinking would boomerang?

law against driving after drinking would boomerang?

**COULD IT BE** that the government's sanction of the liquor which disqualifies one for sitting at the wheel of an automobile has something to do with our reluctance to deal sternly with the problem?

The state which engages in the liquor business for profit, or the federal government which profits substantially from the tax levied on intoxicants, isn't in the best of positions to judge harshly about what is done after the product is consumed.

Whatever the explanation, there is no fair question about the role intoxicants play in the killing and maiming on our highways. Let me dip into what I regard as the last word on this subject, the most recent "Fact Sheet on Drinking and Driving" put out by the National Safety Council.

It starts out by noting that a drinking driver was involved in at least 30 per cent of all traffic accidents in 1957 and that 23 per cent of all adult pedestrians killed that year had been drinking.

**BEFORE GOING FURTHER,** I'd like to pause for a footnote or two on these figures — 30 per cent of all fatal traffic accidents and 23 per cent of all pedestrian deaths involving liquor. I know, and so does every other newspaper editor, that these estimates are appreciably lower than they should be.

The story is simple. Unless the fact of intoxication, or imbibing, is unmistakable and demonstrable in a court of law, a newspaper wants no part of the responsibility in fixing the blame on liquor. To do so would be to invite court action and defending itself in court isn't the business of a newspaper. To a somewhat lesser extent, law enforcers have this same approach.

It's this which prompted the National Safety Council to include this observation in its report on drinking and driving:

"In many accident cases, the fact that a driver has been drinking is not recorded and is never entered on the driver's official record."

**"IN SPITE OF PAST** and present efforts to increase safety education and traffic enforcement, too many drinking drivers are still operating on our streets and highways.
