Today, in Springfield, Massachusetts, in a city square, there is a statue of Deacon Samuel Chapin.

Succeeding generations continued to live in the New England area, although some had migrated to New York. The eighth generation ancestor, Lyman Chapin, moved with his parental family to Bloomfield, Wisconsin, and then later, with his wife and one daughter, moved to a farm south of Tripoli, Iowa, in 1860.

The ninth generation ancestor, Arthur D. Chapin, was born in 1866 at Tripoli, Iowa. The tenth generation ancestor, Kenneth Arthur Chapin, was born in 1894, also at Tripoli, Iowa. Merlin Kenneth Chapin, of the eleventh generation, was born at Waverly, Iowa, in 1928.

Patricia Mary (Klose) Chapin was born in 1930 in Gawler, South Australia. Patricia is a descendant of German migrants who settled, about 1850, in an area north of the city of Adelaide, South Australia, now known as the Barossa Valley. The rainfall in the valley is not plentiful, about seventeen inches annually, so the original settlers planted grapevines and established a wine industry that exists to this day.

The acquaintance of the Chapin and Klose families occurred during World War II, when school children were encouraged to write letters to a pen pal in another country. By chance, Patricia and Merlin's sister Betty became pen pals.

Of Merlin's siblings, his sister Betty lives in Los Angeles; his brother William was killed in a military accident while in the US Army in Germany on 28 June 1953; sister Patricia lives with her family at Tripoli, Iowa.

Merlin Chapin has three descendants, the oldest, Michael William, the son of a previous marriage, was born in 1954. He is a Reserve Army officer and is presently attending school at Illinois State University in Normal, Illinois, working on his second graduate degree.

The second son, Brenton Kenneth, born 1967 at Des Moines, Iowa, is presently a high school student, but will be attending Texas Tech in 1985 studying Computer Science.

The third son, Derek Andrew, was also born in Des Moines, Iowa, in 1970, and is currently an eighth grade student.

Merlin is a graduate of Tripoli High School in the class of 1946 and an engineering graduate of Iowa State University in 1950. Military service was with the US Army in the years 1951 to 1953, with overseas service in Korea.

The Merlin Chapin family has lived in the Ankeny and Marshalltown, Iowa, areas, but in 1977, in a company-wide move, the family relocated in the Dallas, Texas, area and is now living in the bedroom community of The Colony, Texas.

In June and July 1983, the entire family visited Australia, so the two sons could visit their mother's homeland and also become better acquainted with their relatives in Australia.

In June and July 1984, the family toured Europe, visiting the countries of England, Belgium, The Netherlands, West Germany, Austria, Italy, Switzerland, and France. Patricia visited Europe on several occasions in her youth and lived in London four years, so it was a return venture for her.

Patricia is a music graduate of the Elder Conservatory of Music, University of Adelaide, Adelaide, South Australia. She won a music scholarship and spent two years in London studying the violin. She has played with the South Australian Symphony Orchestra and during the time, while living in Iowa, played with the Iowa State University Orchestra, both the full orchestra and chamber groups. She also performed in the pit orchestra, in conjunction with musical performances, for a number of years in the 1960s and 1970s.

## ELMER AND EDITH CHESTER

Elmer Chester and Edith Stickman were married on June 7, 1925, in her parents' home in Plainfield. Elmer was farming west of Plainfield with his parents and brothers. Edith had been teaching in a rural Bremer County school.

They farmed for thirty-three years west of Plainfield. They were engaged in general farming with their parents and brothers. Edith had been teaching in a rural Bremer County school. They moved to Plainfield in 1959. Edith had returned to college at the University of Northern Iowa in 1956

and then taught for six years in area schools. Elmer was custodian at Plainfield Community School for ten years before retiring.

He was born in Bonfield, Illinois, on January 18, 1902, the youngest child of Frank and Anna Walters Chester. When he was seven years old, they came to the farm two miles west of Plainfield, where he grew up. He attended country school there and, later, Plainfield High School. His ancestors trace back to Elder Brewster, who came to America on the Mayflower in 1620. (A Brewster daughter married a Chester.) His mother's family came from Germany in the mid-eighties.

Edith was born at Nashua on January 24, 1906, to Fred and Maud Briggs Stickman. Both came from farm families, but Fred became a buttermaker. Edith's mother taught school for several years. The family moved to Plainfield in 1921, and Edith graduated from Plainfield High School in 1924 and then attended Iowa State Teachers College.

Edith's lineage traces to and before the Mayflower's coming. Her Briggs ancestors came in 1621 and settled in Vermont, where cousins still live. One well-known cousin was Calvin Coolidge. The Stickman grandparents came from Germany about 1867 and farmed in the Republic area.

The Chesters have been members of the United Methodist Church in Plainfield for over sixty years. They were on the Building Committee of the present structure and served on various boards throughout those years. At present, Edith holds offices in the church. She has been especially active in Iowa Federation of Women's Clubs for over fifty years. Both she and Elmer served on the Farm Bureau Board and on FHA Advisory Board for several years in neighboring Butler County. Edith was on the first board of the Bremer County Historical Society and the first board of Plainfield Library, which she helped establish. Both served on the City Council, and Elmer was a bank director of the Plainfield Bank for over thirty years.

They have two daughters, Ellen (Mrs. Frank O Meara) of near Fergus Falls, Minnesota, and Carol (Mrs. Richard Ridenour) of Cedar Rapids. There are seven grandchildren, Ellen having four children and Carol three.

Fishing is Elmer's favorite recreation in warm weather, and in winter, he enjoys playing cards. Edith likes reading, travel, handwork, and collecting art objects. Both have travelled throughout the United States and much of Mexico and Canada. Edith has made several trips to Europe in addition to the trip she and Elmer and friends made in 1967. Recently, she went on a cruise ship to Alaskan ports and on the Danube River, visiting Eastern Bloc countries and Istanbul, Turkey.

## CLARENCE C. AND ESTHER WALTERS CHRISTOPHEL

Clarence C. Christophel was born September 24, 1910, Bremer County, Iowa, son of Geo. W. and Edith Wehling Christophel. He graduated from Wartburg Academy in 1929 and continued farming with his parents.

He married Esther Walters February 26, 1935, at Dunkerton, Iowa, in the home of her grandfather, a retired Evangelical minister. Her great grandfather was a founder of Trumbo Grove Church, the present Warren United Methodist Church. They began farming southwest of Waverly; the farm in early years was a stagecoach stop.

Esther, daughter of Fred W. and Nora Trumbauer Walters, was born March 8, 1911, at Coster, a small town eleven miles southwest of Shell Rock. When Esther was four years old, the family moved to Colorado because of her mother's health. Her mother died in 1916. Her father and the children moved back to Iowa and he married Martha Keller of Waverly.

Esther graduated from the Shell Rock High School and entered nurse's training at Allen Hospital in Waterloo. She graduated in 1932 during the depression, when work was scarce, and became night supervisor at Allen Hospital. Salary was a dollar a day with room and board. General duty was six dollars for a twenty hour day, and only the wealthy had special duty rates. After marriage she continued nursing until one day upon arriving home, she found Clarence

eating soda crackers and whipped cream; he was no cook. He said, "Either you quit work or we quit farming": from then on, my career was farming.

Two children were born to this marriage, Richard of Waverly, a farmer, and Elizabeth Erkel of Corpus Christi, Texas, an associate director of nursing in the Corpus Christi University. There are seven grandchildren.

Clarence and Esther retired from farming in 1971 and moved to Waverly. Clarence died in September, 1972. At the time of his death, both were members of Faith United Methodist Church in Waverly.

Clarence was active in church work and served on the board. He was active in community work, served on the Farm Bureau board, C&H Oil Co. board, Farmer's Exchange board, Farmer's Home Administration board, and taught a G.I. farming class. He was elected a Republican member of the House of Representatives for the 55th, 56th, and 57th General Assemblies. Esther is active in Farm Bureau and Extension work and was chosen Bremer County Homemaker of the Year in 1965. ## GEORGE CHRISTOPHEL FAMILY

In 1911 and 1912, he served as secretary of the Bremer Creamery Company. In 1913 he moved to a farm three miles northwest of Waverly. He was president of the Bremer County Farm Bureau two years and vice president two years. He was elected twice to the Iowa Federation of Farm Bureau and awarded a gold medal, January 13, 1927, in the Master Farmers Contest. He helped organize the Farmers Reload Association in Waverly. In 1930 he was elected the first president of that association and was re-elected president in 1931. He was elected state representative in the fall of 1924, re-elected in 1926, and elected senator in the fall of 1928.

George was prominent in farm activities. He had a test plot for fertilizer on his farm for twelve years, which was sponsored by Iowa State University, Ames.

He was an active member of First Evangelical Church, now known as Faith United Methodist of Waverly. He held various offices, taught Sunday School, and also served in the Iowa Conference meeting.

## LAVERNE AND HELEN CLARY FAMILY

Laverne R. and Helen L. Clary are both graduates of Waverly High School. They were married in Princeton, Missouri, on October 22, 1942. To this union were born three children: Dianne Lucille, who died in infancy in 1946; Michael L., born July 25, 1948, who lives in Waterloo and is employed as a chef in Hudson, Iowa; and Margaret H. They also had one daughter, now Mrs. Lucille Clary Lee, who lives in Clinton, Iowa. The family moved to Waverly, Iowa, from the Alcock farm in Douglas Township in 1924.

Charles and Elizabeth Peacock Alcock were the parents of Elizabeth Alcock Clary. At the time of her death in 1870, Mrs. Alcock asked to be buried on the Alcock farm. Later this area was made into a cemetery. Thus, she became the first to be buried in what is now the Alcock Cemetery.

Helen was born on January 24, 1923, in Waverly, Iowa, the daughter of James A. and Daphne L. Martin Curry. She has one sister, Mrs. Jean Williamson, living in Port Angeles, Washington. A brother, William M. Curry, died in 1964 in Renton, Washington.

At the time of their marriage, Helen was employed by Northwestern Bell Telephone Company as an operator, and Laverne was working for the Waverly Feed Mill. He entered the United States Army on September 8, 1943, and served as Supply Sergeant in Battery "B," 394th Field Artillery Battalion. After a short tour of duty in the European Theatre, he was discharged as a Staff Sergeant on February 6, 1946.

On June 3, 1946, he began working for the U.S. Postal Service in Waverly as a city carrier, and in 1969, he transferred to the Rural Carrier Division from which he retired on December 1, 1978, with nearly 35 years of government service.

In 1946, he became a member of Tyrell Lodge #116, Ancient, Free and Accepted Masons in Waverly and continues to be an active member in this fraternity. He served the local lodge as Worshipful Master in 1953.
