Funeral for Merle Hagedorn, 63, of Royal will be Friday, Feb. 21 at 1:30 p.m. at the Bethlehem Lutheran Church in Royal. The Rev. Russell Schilling will officiate.

Burial will be in Northlawn Cemetery in Spencer. Mr. Hagedorn died Feb. 17 in Pharr, Tex.

He was born March 14, 1911 near Royal and was a lifetime resident of Clay County. He graduated from Rossie High School and attended Dana College in Blair, Neb.

He was married to Lucile Weik Nov. 30, 1932 at Royal. He farmed for many years. In 1954 Mr. Hagedorn was elected as a representative to the Iowa Legislature.

He served as a representative until 1966 when he was elected to the Iowa Senate where he served until 1969. He was the House minority floor leader and also assistant floor leader.

His county activities included serving on the Clay County Board of Education and as Lincoln Township assessor. He was on the Iowa District Board of the American Lutheran Church.

Survivors include his wife; two daughters, Mrs. Doug (Marcel) Magnussen of Hartley and Mrs. Loren (Pauline) Azbel of Belton, Tex.; one son, Dean of Royal; nine grandchildren; his father, George of Royal and one brother, Wesley of Royal.

Zip Codes were used on 91 per cent of the total national mail in 1974

ZIP Code has come a long way since its adoption more than a decade ago, Postmaster Dan Maxwell said in reporting that ZIP Code was used on more than 83 billion pieces of mail in fiscal 1974.

Maxwell said the ZIP Code was carried on more than 91 per cent of the total national mail volume of 90.5 billion moved during the year. ZIP Code was launched by the postal system in July, 1963.

On first-class mail, where its use is voluntary, 45 billion letters carried the ZIP Code - 90 per cent of total first-class mail volume, Maxwell said.

There are many correspondents, however, who still don't realize how important the five numbers are to the prompt and economical sorting of their mail, the postmaster said.

Last year 5 billion first-class letters weren't ZIPped, Maxwell said, and failure to code these letters is estimated to have

delayed delivery by one day for at least 50 per cent of them.

In addition to slower service it costs the Postal Service more to handle a non-ZIPped letter. Maxwell said the estimated added cost in 1974 amounted to \$50 million.

He explained that letters without ZIP Codes require handling by clerks who have memorized the locations of almost every street in a city or know from memory that a letter is despatched through a certain city to reach a given destination.

Today billions of letters are sorted one or more times on letter sorting machines. Clerks have less than one second to read an address off the machines. ZIP Codes make this possible. If there is no ZIP Code, clerks hit a key on the sorting console which sends the letter to a bin for non-ZIP Coded letters.

More than an hour can be lost before the letter is "back on track" again and ready

MR. PRESIDENT: Your committee, appointed to prepare a suitable resolution commemorating the life, character and public service of the late Honorable Merle W. Hagedorn, begs leave to submit the following memorial:

Merle W. Hagedorn was born March 14, 1911, on a farm near Royal, Iowa, the son of George Hagedorn and Clara Christensen. He graduated from high school in Rossie, Iowa, and attended Dana College.

On November 30, 1932, Mr. Hagedorn was married to G. Lucile Weik. They had three children: one son, Dean, and two daughters, Macel and Pauline.

Mr. Hagedorn's lifetime occupation was that of a farmer and real estate broker. He was a former Lincoln Township Assessor, a former member of the Clay County Board of Education and former member of the Iowa District Board of the Lutheran Church. He was a lifetime member of the Royal Lutheran Church.

Mr. Hagedorn was elected to the Iowa House of Representatives from Clay County in 1954 and served during the Fifty-sixth, Fifty-seventh, Fifty-eighth, Fifty-ninth and Sixtieth General Assemblies and was elected to the Iowa Senate in 1964 from Dickinson and Clay Counties and served in the Sixty-first General Assembly. In 1967, due to reapportionment of the Iowa Senate, he represented Buena Vista and Clay Counties in the Sixty-second General Assembly. He served as a Minority Floor Leader and as Assistant Majority Floor Leader in the House.

Mr. Hagedorn passed away on February 17, 1975, at the age of 63 years. He is survived by his wife, G. Lucile, one son, two daughters, his father, a brother and nine grandchildren.

Therefore, Be It Resolved by the Senate of the Sixty-sixth General Assembly of Iowa: That in the passing of Merle W. Hagedorn, the state has lost an honored citizen, and a faithful and useful public servant, and the Senate by this resolution would express its appreciation of his service to his community, state, and nation and tender its sympathy and kindest regards to the members of his family.
