If they are unable to continue delivering coal in the meantime, this brings on a serious financial problem for them along with the fact there will be an increased cost to the University to purchase other coal from another state.

This was the first opportunity I have had to be present when the Federal Environmental Protection people and the Iowa Department of Environmental Quality people testified at the meeting. In my opinion there has always been a tendency for each of these agencies to blame the other when not present. At the close of our meeting we got reserved commitments. They have agreed to meet again on Tuesday of next week and attempt to reach a compromise by possibly blending some cleaned coal with raw coal to bring the emissions into tolerance. I am sure that something can be done, agreements can be reached and we will be watching and monitoring the progress of these agencies next week.

In Arizona**

Joseph B. Flatt, 58, former well-known Winterset resident, died Monday, March 10, in Arizona. He had been a resident of Sun City, Arizona since the fall of 1978.

Mr. Flatt came to Winterset shortly after service in World War II, and became a prominent clothier, state legislator, church leader and National Guard commander.

The family moved to Ankeny, Iowa in 1969.
