Correctionville is a sadder town this week than it has been for a long time. It has lost one of its most loyal sons. Few men can hope to become the living symbol that Bert Fullerton was to the community.

Shakespeare once wrote: "Some men are born great, others achieve greatness, and still others have greatness thrust upon them." To those who knew Bert Fullerton, he revealed the traits of a great man (one who achieved it by years of laborious work for civil and social causes) in a quiet, unassuming way.

Whenever a worthy cause presented itself, whenever a leader was needed to transform any ideal into a reality, Bert Fullerton accepted the challenge and proved his worth. Few men will ever devote as much of their lives to civic causes as he did.

In him, the terms grass roots took on a refreshing meaning. A life-long resident of the Correctionville area, Mr. Fullerton had a charisma that made him a friend of all. No matter what venture he attempted, it was never for personal gain. When he sought office, it was only to help those around him.

If some of us are born followers and other leaders, Bert Fullerton was a leader in the truest sense of the word. He made people think they were with him and not under him. And yet no scandal ever marred his lengthy record of public service..

In November, for example, he gave the Correctionville News freely of his time even though it was obvious to those assigned the duty of interviewing him that Mr. Fullerton was not a well man. His face was drawn and he was obviously in pain, but he talked on the public issues facing this legislative district as though they were really the only things that mattered. He cited land use bills, corporate farming, and packer bonding as key issues for his constituents.

He spoke out for what he felt was right. He favored the 60-mile an hour speed limit. "That seems to be the speed at which new cars run best," he said. He felt the populous eastern half of Iowa ruled the less populated western

Property Tax Reimbursement

LaRae Lyons, outreach worker from the Woodbury County Community Action Agency, in Sioux City, announced the 1976 Iowa Disabled and Senior Citizens property tax and rent reimbursement is now in effect.

The following IOWA RESIDENTS are eligible to file a claim for reimbursement of property tax or rent paid if reportable income is less than \$8,000:

1. Any person 65 years of age or older by December 31, 1975.

2. Surviving spouse, unmarried at time of filing this claim, who was 55 years of age or older by December 31, 1975.

3. Any person totally disabled. (Totally disabled means the inability to engage in gainful employment because of a major physical or mental impairment which has lasted 12 months or is expected to last 12 months.

If two or more persons occupying a homestead qualify for the reimburse-

he had entered on Jan. 5. Mr. Fullerton
was 73.


Officials in the general assembly said
Fullerton, who represented house dis-
trict 49 in Cherokee, Plymouth, and
Woodbury Counties, had been excused
from legislative duties for this session;
however, an election is scheduled to
name his replacement.

In his life, he worked as a farmer and
livestock feeder. He was a member of
the United Methodist Church, Masonic
Lodge, Eastern Star, Scottish rite and
the Shrine.

He is survived by his wife, Frances, a
daughter Mary Myers of Grand Blanc,
Mich.; a son, Rev. Dean Fullerton of
Des Moines; a step-daughter, Pat
Rasmussen of Cushing; two brothers;
three sister; five grandsons; and three
step-granddaughters.

Funeral services were held at 10:00
a.m. Wednesday at the United Metho-
dist Church of Correctionville. Burial
was in the Correctionville cemetery.

Secretary of State Melvin Sunhorst,

MR. SPEAKER: Your committee, appointed to prepare a suitable resolution commemorating the life, character and public service of the late Honorable Bert Fullerton, begs leave to submit the following memorial:

Bert Fullerton was born October 11, 1902, in Correctionville, Iowa, farming in that area all of his life. He also was a livestock feeder and farm-power contractor.

He was first married to Laura Brune who died in 1962, and in 1967 he married Frances Hayes. He was a lay leader and Sunday School teacher at the United Methodist Church in Correctionville. He served eight years on the Correctionville Board of Education, was a member of the town council and served 22 years as township clerk.

He was a member of the Masonic Lodge, Eastern Star, Sioux City Consistory and Abu Bekr Shrine, and, in addition, was very active in the Republican party in his area.

Mr. Fullerton, a Republican, was a member of the Sixty-second, Sixty-fifth and Sixty-sixth General Assemblies, representing Cherokee, Plymouth and Woodbury Counties.
